- 2 The successful tenderers are require to execute an agreement bond on non judicial stamp paper of Rs. 20/- as per specimen enclosed(Annexure B)
- 3 Tenderers must fill their rates in the Tender Form(both)in words and figures and return duly signed in token of acceptance of the conditions laid down herein as per specimen enclosed.
- 4 No alteration shall be made to any of the terms and conditions of the tender by scorching out, altering, overwriting and no alteration are permitted in their rates. No alteration will be allowed in filling the tenders.
- 5 In case of selected tenders, the earnest money will be refunded at the time of expiry of the contract and EMDof unsuccessful parties shall be refunded immediately after finalization of contract.
- 6 The Corporation is not bound to accept the lowest rates and can reject any or all Tenders without assigning any reasons. It reserves the right of accepting the whole or part of the offer made. The decision of the Corporation in this matter shall be final and binding.
- 7 The Corporation may decide to split the storage of seed Potato among two or more cold storages at its discretion.

- 8 There should be alternate arrangement of a Generator of suitable capacity as a stand by measure for the operation of the plant during electric shut off.
- 9 The Cold store should have enough space for sorting drying and packing of Seed Potato.
- 10 The road should be easily approachable preferably the store should be situated on the high way.
- 11 There should be facilities of temperature cooling chambers.
- 12 Any tender received without earnest money of Rs. 5000/- will not be considered.
- 13 Any tender received after the due date and time will not be considered.
- 14 The Corporation does not guarantee the quantity mentioned in the Tender Notice. The quantity maybe decreased or increased.
- 15 The tenders will be opened on 08-01-2010 at 3.00P.M. in the office of National Seeds Corporation Ltd., C 25 Focal Point, Jalandher in the presence of tenderer or their representative, if any.

This agreement made at _____ of this _____ day of _____ two thousand ten _____ between the National Seeds Corporation Ld. A company registered under the Companies Act 1956(with registered office at New Delhi(who and whose successors and assigns are herein after called NSC of the one part) and _____

(name and address in capital letters)who and whose heirs, legal representatives and successors herein after called the “Party” of the other part) Whereas the party agrees to store NSC Potato Seed .Class of _____

Now this agreement witnessth:

- 2 That the NSC hereby agrees to store _____ qtls Potato Seed packed in _____ Nos.of 50 Kg Gunny bags in the Cold Storage belonging to the party in the year _____ @ Rs. _____ per qtl.Further NSC agrees to pay Rs. _____ per qtl on account of drying, sorting and rebagging charges of seed Potato
- 3 That the use Of Cold Storage of the party will start from the 1st week of Feb 2010 and will continue till 31st December 2010.
- 4 That the party shall keep daily record of temperature and humidity maintained under the cold storage and make it available for the inspection to the representative of the NSC as and when required. The party shall maintain the temperature in the chambers between 34 degree F to 38 degree F with 80% to 85% relative humidity.

- 5 The total driage, rottage and shrinkage, if any during the Storage up to 31st December 2010 should not exceed 5% of total variety wise/class wise quantity stored.

- 6** That the party shall be responsible for any spoilage i.e. damage to the seed potato including rottage, deterioration gas damage, sprouting, driage, frosting and damage due to poor aeration /maintenance of Cold Store. Condition of the eyest beyond chitting stage will be taken as sprouting. The party shall be liable to pay the cost of the Seed Potato NSC's at sale rates after cold storage variety/stage wise existing at the time of keeping in cold storage plus 18% interest on the compensated amount for the period up to the date on which amount compensation is paid t the NSC for the stock deterioration of the nature mentioned above and in that even shall also not be entitled to charge hire charges for the damage quantity.
- 7** After accepting the seed potato of NSC for the storage the party shall issue a cold storage receipt indicating the number of bags, weight and value of seed potato as per NSC prevalent rates. In the receipt it will be specified that quantity of produce accepted for storage is to the entire satisfaction of the party. The receipt must be issued to NSC authorized official as soon as produce is handed over for storage.
- 8** The party will release the seed potato only to the authorized NSC representative as and when required after obtaining a proper receipt.
- 9** The party will follow the procedure of turning the seed bags at their cost in the month of July/August and when required.
- 10** The claim in the event of the deterioration of stock as in clause 5 will be made good by the party within 15 days from the date of receipt of the claim lodged by NSC

10 The handling charges on account of unloading from trucks and keeping in cold storage and taking out of cold storage and loading into trucks will be borne by the party. The party shall provide sufficient space and facilities for sorting, drying and bagging etc. on the date be indicated by NSC so that daily supply of seed may run smoothly. The cost of drying, sorting and re bagging will however be borne by NSC as per Clause 1.

11 The payment of storage chargers will be made by NSC in the part for the quantity lifted in good conditions from the cold storage.

The party will allow the NSC staff for inspection of the cold storage at least once in a month and show the Cold Storage log book and sign the NSC Cold Storage inspection report (specimen enclosed).

iv) In the case of any dispute arising between the NSC and the party in connection with this agreement or any thing arising there under the same shall be referred to the sole arbitrator i.e. Chairman and Managing Director or any Officer nominated by her/him. The award of the arbitrator given in such a reference shall be binding on the party. The party shall not object to the arbitration by the Chairman and Managing Director or his/her nominee on any ground as the party is consciously entering into the agreement. Not with standing the place where this agreement is to be implemented is mutually understood and agreed by and between the parties here to that this contract shall be deemed to have been entered into by the parties concerned at New Delhi and the courts of law in New Delhi alone shall have jurisdiction to adjudicate thereon.

v) All the payment which become payable under the agreement shall be made from the office of Regional Manager, NSC SCO NO.1024-25 Sector 22 B Chandigarh.
