

ANNEXURE-I

TERMS & CONDITIONS FOR ANNUAL MAINTENANCE CONTRACT OF COMPUTERS AND PERIPHERALS

1. The participating parties should have Registered office in Delhi.(Proof to be submitted.)
2. Complaints should be attended within 6-8 hours on working days and should be rectified within 24 hrs. failing which it will got rectified at the risk and cost of the maintenance contractor and the same will be acceptable to them without any dispute.
3. The defective parts should be replaced with **genuine OEM parts.**
4. The agreement shall remain in-force for initial period of one year from the date of commencement. Thereafter, this can be renewed for further period of one year by mutual consent on merit basis.
5. Payment shall be released on **quarterly basis in advance** after receipt of **Bank Guarantee of matching quarterly payment valid for one year.**
6. Service Tax will be made as applicable/permissible as per rules.
7. All disputes, differences and questions whatsoever that shall arise between the parties hereto during the continuance of the contact or afterwards, in connection with this shall be referred to a sole arbitrator to be appointed by the CMD, NSC. All such arbitration proceeding shall be held in Delhi and shall be in accordance with the subject to the provision of the Indian Arbitration Act-1940 or any statutory modification re-enactment thereof for the time being in force.
8. Company should preferably deploy an Engineer at NSC, Beej Bhawan, Pusa Complex, New Delhi and sitting arrangement shall be provided by the NSC.
9. The Corporation will retain 10% of the contract value of AMC as security deposit, which would be adjustable for default in service as may be decided by NSC.
