**Terms and conditions for purchase of CS/TL seeds of Oat Kent, out of fresh stock**

National Seeds Corporation Ltd.(A Govt. of India Undertaking) is interested to purchase CS/TL seeds of Oat Kent out of fresh stock on the following terms and conditions:

- 4 Supplier will submit well labeled/sealed representative samples of one kg along with sealed tender. Seed supply will be accepted only if pre-cleaned seed visibly resembles the said representative sample.
- 5 Supplier offer should be valid at least for one month. Supply of the entire quantity by the tenderer required to be completed within 25 days of issue of NSC's purchase order.
- 6 NSC may increase or decrease the indent/requirement from the quantity indicated in the NIT.
- 7 Supplier will deliver the pre-cleaned seed in own gunny bags, which will be returned within 30 days of delivery of raw seed.
- 8 Delivery of seed shall be made at the NSC's nearest processing plant at Jalandher/Karnal/Hissar/Bhatinda. Loading/unloading and weigh- ment shall be borne by the supplier.
- 9 Cleaning/grading/packing will be at NSC's plant on NSC's cost. The graded seed will further be packed in 2 - 30 Kgs packing as per the requirement in NSC's bags. The undersize/rejected seed will be returned to the supplier who would arrange the lifting within 15 days of receiving intimation from NSC.
- 10 The tenderer shall indicate the precise quantity that can be supplied and time schedule for delivery at the location indicated in Sr. No.5.
- 11 The rate should be quoted in Rs per qtl for net final cleaned/graded seed in the enclosed prescribed format.
- 12 Supplier has to ensure Indian Minimum Seed Certification Standard (1988) as per test in Quality Control Lab. NSC New Delhi or any other Lab specified by NSC. Supplier shall lift back the seed stocks not

conforming to the seed standards within 15 days of receiving intimation from NSC.

- 13 Tender can be submitted for any quantity but not less than 200 qtls.
- 14 Tender shall be accompanied with EMD @ 2% of the quoted value or Rs. 50000/- which ever is less in the form of Demand draft in favour of National Seeds Corporation Ltd. Chandigarh. Tender without EMD will be rejected. No interest will be paid on EMD.
- 15 Tenders will be received at National Seeds Corporation Ltd. SCO No.1024-25 2<sup>nd</sup> floor Sector 22 B Chandigarh up to 1.00 P.M. on 14-10-09 and shall be opened on the same date at 2.00 P.M . Tender received after due date and time will be rejected.
- 16 NSC reserves the right to reject any/all tenders without assigning any reason thereof.
- 17 Payment will be released within 30 days from the receipt of bill(s) subject to satisfactory test report and fulfilling other requirements set - out for the final cleaned/graded quantity in required packing as per clause No.6 above.
- 18 The successful tenderers shall furnish formal agreement immediately with NSC for executing the supply as per these terms and conditions.
- 19 The successful tenderer shall remit security deposit @ Rs. 2% of the purchase order or Rupees one lacs which ever is less.. This deposit shall be remitted within seven working days from the date of receiving purchase order/intimation. Failure to remit the security deposit will imply forfeiture of EMD. The EMD of successful tenderer can be adjusted against the security deposit. No interest shall be paid on security deposit.
- 20 In case successful tenderer fails to supply quoted/ordered quantity as per supply order appropriate penalty will be imposed.
