Sir,

National Seeds Corporation (NSC), besides being in the business of production and marketing of certified/quality seeds, has also developed adequate expertise in organizing Training Programme on various aspects of seed production and supply chain management. In the past, NSC training, programmes have been availed of by the officials of the State Seeds Corporations, State Agricultural Departments, State Seed Certification Agencies, State Agriculture Universities, Private Sector Seed Agencies etc. besides the foreign nationals sponsored by FAO & UNDP etc.

Like previous years, NSC is likely to undertake 6 training programmes on Hybrid Seed Production, Marketing of Vegetable seeds, Marketing of Seed and Planting Materials, Seed Processing and Storage, Seed Quality Control and Seed Entrepreneurship Development consisting of 25 trainees in each batch for 2-4 working days duration each programme. The training programmes are aimed to enrich the working knowledge of participants on the concerned subject. A revised training schedule giving details of training programmes, date of training and venue is enclosed at Annex. I.

No fee will be charged from the participant. Moderate hostel facilities will be provided to the participants by NSC on payment of nominal charges and the sponsoring organizations will have to bear to and fro traveling expenses of the participants. There will be 25 seats in the each training course including 5 seats reserved for Officials of NSC. Tentative two-three seats are allocated for your organization subject to our confirmation and in case you are interested in nominating more candidates, please forward their application in separate application form for the training programme mentioned in Training Calendar at Sl. No.3, 4, 5, 7, 9 & 10 for each candidate as per enclosed nomination form (Annex. II).
