2. The Financial Statements for the year 2017-18 have been forwarded to the Comptroller and Auditor General of India (CAG) U/s 143(6) of the Companies Act, 2013. The comments of the CAG which could not be released earlier and therefore it were not placed before the AGM scheduled for 29.09.2018, are likely to be received from the CAG before 29.10.2018 and therefore the same will be placed before the Shareholders at the adjourned Annual General Meeting scheduled on 29.10.2018.

In order to avoid needless delay, Financial Statement of NSC alone will be placed before the adjourned AGM. As informed earlier in the AGM Notice dated 05.09.2018, matter has already been brought to the Notice of MOA&FW who are the Administrative Ministry of the NSC.
