**SUBJECT: DEBARMENT DUE TO NON-SUPPLY OF BOPP BAGS 30 KG CAPACITY
AGAINST GEM ORDER NO. GEMC-511687736706608 DATED 13.01.2025**

Dear Sir/Madam,

This is with reference to bid GeM bid: **GEM/2025/B/4419477** dated **01.01.2024**, a GeM Child Contract Order **GEMC-511687736706608**, dated **13.01.2025**, placed through the Government e-Marketplace (GeM) portal for the supply of **3,90,000 nos. of BOPP Bags 30 Kg capacity**.

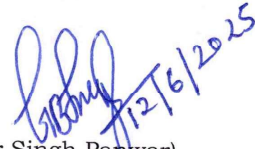
Despite repeated reminders vide e-mail dated 01.02.2025 & 14.02.2025, you have failed to fulfil the supply order obligations like confirmation of artwork for the bag, submission of Performance security, Indemnity bond and supply of 50% quantity within the stipulated delivery period of 30 days (**13.02.2025**) & complete supply in 60 days (**14.03.2025**) from the issuance of supply order and sufficient time granted failing which a Show Cause Notice was also issued to your firm vide letter dated **22.02.2025** to which your firm no response received from your firm. This constitutes a clear violation of the contractual terms agreed upon at the time of order placement.

As per **Clause 19 of the GeM General Terms and Conditions**, titled "Termination for Default", If the Seller does not perform its obligations mentioned in the contract, the same would constitute the breach of contract & buyer shall have the right to Cancel or Withdraw the contract & would entitle buyer for actions including **forfeiture of Performance Security besides administrative actions such as debarment of the firm**. Referring to the clause, the order was cancelled on **20.03.2025** causing operational inconvenience to our organization, adversely affecting our scheduled activities of material supply and further packaging of seeds on timely basis

In view of the above, it is to inform you that your firm is being **debarred from participation in any future procurement through GeM or any other medium** by our organization, for a period of **Two Years** from the date of issuance of this letter. We will also be reporting this breach on the GeM portal for further necessary action as per the platform's policies.

You are requested to treat this letter as a formal notice of debarment.
