Subject: Blacklisting/Debarment for Submission of Wrong/Fake Documents in Tender

Sir,

With reference to the Show Cause Notice No. NSC/MM/ET/2025-26/59 dated 01.11.2025 issued to your firm regarding the submission of incorrect and misleading documents towards past performance in response to the GeM Bid Nos. GEM/B/2025/6350224 dated 16.06.2025 and GEM/B/2025/6350403 dated 16.06.2025, it is noted that your firm submitted Purchase Orders as proof of supply which were subsequently verified and found to be false by the concerned issuing authority — the Indian Postal Department, vide their confirmation dated 03.09.2025.

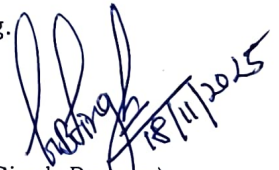
Despite being given an opportunity to explain your position, your reply was found unsatisfactory, and the act of submission of fake/incorrect documents amounts to a serious breach of integrity and a violation of tender terms and conditions, you are liable to be blacklisted/debarred as per General Terms and Conditions Clause No. 21: Grounds for Administrative Actions subsection (ii)-(f) "Seller furnishing inaccurate, false, misleading or forged or fails to furnish any information/documents"

Accordingly, with the approval of the Competent Authority, it has been decided to debar/blacklist your firm as per the GeM Terms and conditions, M/s. Empire Textiles, Ajmer, for a period of one (01) year from the date of issue of this letter, from participation in any future tenders or procurement activities of NSC.

However, it is also decided that the payments for contract orders already issued to your firm under the above tenders shall be released only after completion of all due diligence and subject to satisfactory fulfilment of contractual obligations pertaining to the respective purchase orders.

You are requested to treat this letter as a formal notice of debarred/blacklisting.
