Subject: Order for Blacklisting under NIT & GCC Clauses for Wilful Default – Roofing Work at NSC Area Office, Raichur

Sir,

This has reference to the Work Order dated 01.01.2026 issued to you for execution of Roofing Work at NSC Area Office, Raichur, which has been cancelled at your risk and cost vide cancellation order issued under Clause 14.1 and 14.2 of the General Conditions of Contract (GCC) due to non-performance and wilful default.

It has been conclusively established on record that you have committed the following contractual violations:

- 1) Failure to commence and proceed with the work with due diligence, in violation of Clause 14.1(i) of GCC;
- 2) Failure to comply with contractual obligations and official instructions despite repeated reminders, attracting action under Clause 14.1(ii) of GCC;
- 3) Failure to adhere to the stipulated time schedule and subsequent refusal to execute the work, amounting to abandonment of work under Clause 14.1(iii) of GCC;
- 4) Acts prejudicial to the interest of the Corporation, attracting action under Clause 3 (Contractor's Obligations) and Clause 5 (Time is the Essence of Contract) of the NIT;
- 5) Conduct lacking integrity and reliability, attracting disciplinary action as per CVC Guidelines on Banning of Business Dealings / Blacklisting of Contractors and CPWD Works Manual provisions relating to defaulting contractors.

The Committee constituted for review of the matter, after detailed deliberations, has unanimously concluded that your actions constitute wilful default, breach of trust, and deliberate non-performance, which is detrimental to public interest and undermines the principles of transparency, accountability, and probity in public procurement.

Accordingly, with the approval of the Competent Authority, and in exercise of powers conferred under the NIT, General Conditions of Contract, and applicable CVC/CPWD guidelines, M/s Gowri Shankar Construction, Bangalore is hereby **BLACKLISTED** by National Seeds Corporation Ltd. (NSC) for all present and future works of NSC, with immediate effect, until further orders.

It is further ordered that this blacklisting decision shall be formally intimated to all Karnataka State Government Departments, State PSUs, Autonomous Bodies, and allied organizations for information and necessary action, in order to safeguard public funds and public interest.

This order is issued without prejudice to NSC's right to:

- Forfeit Performance Guarantee / EMD under Clause 1 of GCC;
- Recover losses, if any, under risk and cost provisions of Clause 14.2 of GCC; and
- Initiate any other civil or administrative action permissible under law.

This issues with the approval of the Competent Authority.
