

The effective date of promotion is 01.07.2016. The financial benefit on promotion will be given with effect from he/she assumes his/her promoted post and charge at their new place of posting within the stipulated joining time period as per rules. In case, an official denies his / her promotion for any reason he / she will be debarred himself / herself from considering for promotion for next two years from the date of issue of this Office Order. After promotion he / she will be placed on probation for a period of one year from the date of his / her joining the post. The period of probation is extendable by one more year if required. They will be deemed to be on probation even after expiry of period of probation till formal orders of confirmation are issued.

The basic pay on promotion will be fixed and orders to that effect will be issued separately. Next annual increment will accrue to them on completion of one year service from the date of joining in the promoted post. Necessary orders with regard to fixation of pay will be issued by concerned Regional / Farm Office in consultation with Corporate Office.

They will be eligible to exercise option for fixation of pay under Rule 6(i) & (ii) of NSC Pay and Allowances Rules (Revised) within a period of one month from the date of joining the post. However, benefit of pay fixation will not be extended to him / her if he /she has been granted MACPS and pay fixation benefit was already given on financial up-gradation of pay scale.
