CIRCULAR

Subject-Extension of CGHS OPD facilities to the retired employees of National Seeds Corporation Limited –regarding.

In continuation of earlier circular no. 9[4]/10-11/NSC/Wel dated 12th February, 2018, pertaining to extension of CGHS OPD facilities to the retired employees of National Seeds Corporation Limited, revised circular shall be read as follow:-

NSC has decided to extend the CGHS facilities only for OPD facilities and medicines on cost to cost basis (without any financial **liability** on the Corporation) to the retired employees of NSC **with effect from 1.4.2018** subject to the following guidelines:-


1. NSC will extend the CGHS facilities to the retired employees of National Seeds Corporation Limited on cost to cost basis as prescribed by the CGHS Authorities. The employees will be entitled to OPD facilities and medicines from CGHS Wellness Centres in Delhi/NCR only.
2. CGHS card[s] will be issued by the CGHS Authorities on receipt of recommendations of National Seeds Corporation Limited alongwith advance payment of requisite service charges at prescribed rates [on cost to cost basis] by the Deptt.of Health and Family Welfare on annual basis and accordingly CGHS cards will be renewed on annual basis on receipt of annual services charges in advance through NSC.
3. NSC will issue CGHS card to retired employees to avail OPD medical facility only and NSC shall not bear expenditure on any kind of indoor treatment as indoor/hospitalization facility under this arrangement as the same is being extended by NSC to its superannuated employees under Post-Retirement Contributory Medical Benefit Scheme.
4. NSC medical facility under OPD shall be restricted upto consultation with Doctors at CGHS and medicines therefrom and will not include any kind of Laboratory charges like Blood Tests, X-ray, Ultra-sound, Sonography, MRI etc., from the CGHS empanelled laboratory/diagnostic centres and the charges paid to such lab/diagnostic centre will not be entertained /reimbursed by NSC.
5. NSC will issue CGHS cards only to those retired employees who make the payment of service charges on cost to cost basis in advance on annual basis at the prescribed rates determined by the CGHS, Ministry of Health and Family Welfare **time to time** which is presently Rs. 15,368/- p.a.

6. The CGHS membership card will be renewed annually by National Seeds Corporation Ltd., on getting the prescribed charges in advance. Failure to get the CGHS membership renewed within the specified time period will lead to de-activation of the CGHS card.

Accordingly, the interested retired employees of NSC, who **want the facility at Delhi/NCR** may deposit their contribution of Rs.15,368/- through DD/RTGS/NEFT as per the attached proforma [for remitting Annual Contribution] in favour of National Seeds Corporation Limited so as to reach the undersigned latest by 28/02/2018.
