
The promotion /placement in next higher scale of pay will be effective from the date mentioned against each of the employee. The Financial benefit on promotion / placement in next higher scale of pay will be given from the date of joining the post and charge at his/her new place of posting within the stipulated joining time period as per the rules. **Refusal to move to new place of posting will be treated as refusal of promotion/placement in next higher scale of pay issued under this order and will be debarred himself/herself from considering for promotion / placement in next higher scale of pay for next two years as per clause 8.3 of Modified Promotion Policy under Cluster Scheme from the date of issue of this office order.** After promotion, he/she will be placed on probation for a period of one year from the date of his/her joining the post. The period of probation is extendable by one more year, if required. He/She will be deemed to be on probation even after expiry of period of probation till formal orders of confirmation are issued.

His/her basic pay on promotion / placement in next higher scale of pay will be fixed and orders to that effect will be issued separately. Next annual increment will accrue to him on completion of one year service in the promoted grade/placement after joining. Necessary orders with regard to fixation of pay will be issued by the concerned Regional/Farm Office in consultation with HR Department, Corporate Office. However, benefit of pay fixation will not be extended those employees who have been granted financial benefit under MACPS & Selection Grade earlier.



The above officials are eligible to exercise option for fixation of pay as per Rule 06 of NSC Pay & Allowances Rule (based on FR-22) within a period of one month from the date of joining the post.

The expenditure involved is debitable to the head – “Pay & Allowance of respective Regional Office/Farm Office/Corporate Office.”
