### CORRIGENDUM

Following Amendment is being made in our NIT No. IT-2812 dated 09.05.2018 invited supply, installation and commissioning of machines of Seeds Processing Plant on Turnkey Basis and AMC for five Years from eligible & qualified manufacturers / suppliers, which is uploaded on NSC Website i.e. <https://indiaseeds.eproc.in> [www.indiaseeds.com](http://www.indiaseeds.com)

1. Clause No. 12 (b), Section II – Instruction to renderer, PART-A which may read as below:

**“Exemption of earnest money deposit for Indian Manufacturers which are registered with NSIC under Single point registration scheme: Indian manufacturers/suppliers who are Micro Small Enterprises (MSE’s) and registered with National Small Industries Corporation under single point registration scheme are exempted from payment of earnest money deposit provided to furnish photocopy of valid registration with NSIC under the single point registration scheme, for the quoted stores in support of claim along with their request letter. This facility will, however, not be provided to those small scale units who are registered under the old registration scheme which was extended up to 30th June, 1981 only.**

The MSE units claiming exemption of Tender cost/EMD should submit MSME UDYOG ADHAR MEMORANDUM along with registration certificate issued National small industries commission (NSIC). The memorandum/certificate shall clearly indicate the monetary limit and shall be valid as on due date/ extended due date of the tender. Also it should cover the items tendered to get EMD/Tender fee exemptions.”

2. S.No.4 of Section-IV Form for Technical Bid, Annexure – A in which the average annual turnover in last three year for **Micro Small Enterprises (MSE’s) and registered with National Small Industries Corporation under single point registration scheme should not be less than 3 time of estimated value/ value quoted item/ Items of offers whichever more**

The MSE units claiming relaxation of prior turnover should submit MSME UDYOG ADHAR MEMORANDUM along with registration certificate issued by District industries Centre (DIC)/ National small industries commission (NSIC) or any other body specified by Ministry of MSME. The memorandum/certificate shall clearly indicate the monetary limit and shall be valid as on due date/ extended due date of the tender.”

Other terms & condition of tender will be remaining same.
