National Seeds Corporation Limited (NSC) has established a Tissue Culture Laboratory **at Plot No.150, Industrial Estate, Mancheswar, Bhubaneswar, Orissa** with a plinth area of 350 sq.mtr. approximately. The laboratory has a media preparation room (11' x 21.8", production room (of 23.5' x 26') a checking room and two growth rooms of 23.5' x 32' and 19' x 25' size with a production capacity of about 10 lakh tissue culture plants annually. Necessary equipments and other provisions required like racks etc. have also been provided. Besides a Poly house of 800 sq. mtr is also available for hardening. NSC is desirous to hand over the fully equipped facility for production and marketing of tissue cultured plantlets to the successful tenderers. Interested parties may visit the site at the above mentioned address.

Tenderers will be allowed to produce tissue culture plantlets of banana / potato tuber/ pineapple / bamboo etc. which they may sell by themselves by paying a royalty for each plant to be produced and sold by them. NSC will be willing to allow the successful tenderer to sell about 60 to 75 per cent of the total plantlets produced by themselves and the remaining about 25% may be utilized by the Corporation for own sale. In case of purchase by NSC, the purchase rate will be decided by mutual consent. The desirable production level will be not less than 75% of the production capacity of the laboratory.

NSC invites EOI from reputed agencies who would be interested to utilize this facility for production and sale of tissue culture plants. The contract will be valid for a period of three years initially which can be extended further on mutually agreed terms.

Interested parties may submit their bid by the due date fixed for submission of tender. The tenderer should have following competence;

1. The procedures / protocol should be owned by the tenderer.
2. Tenderer should have prior experience in the production and sale of the tissue culture plantlets which should be proved by documents.
3. Tenderer should use their own technical staff, protocol, and mother plants to undertake the production. They should also furnish the details of tissue culture work done by them.
4. Tenderer having previous experience in working with any Government tissue culture laboratory with similar terms and conditions of the tender will be preferred.
5. Tenderer having experience in regularly exporting tissue culture exagar plants will be preferred.
6. Tenders of those parties, who had defaulted earlier in carrying out operation in the said establishment, will not be entertained.

TWO BID SYSTEMS

Two independent sealed envelopes should be prepared as detailed below:

- Envelope No.1 (Sealed):- This envelope should be marked as Technical bid and should contain papers with covering letter on letter head (with name, address etc. on left side of the envelope) giving the detailed technical information as required vide Part-A of the tender document. EMD amount be kept in the sealed envelop failing which commercial bid will not be considered.
- Envelope No.2 (Sealed):- This envelope should be marked as Commercial bid and should contain royalty rate offered by the party as detailed vide PART-B of this tender.
- Both the envelopes should be inserted in one big size envelope (sealed), super scribing “Expression of interest for Production and sale of Tissue Culture Plantlets” – to be opened on 19.12.2018.
- The tender should be delivered in the office of **Regional Manager , NSC Ltd., at SECTOR-V, BLOCK-AQ, PLOT NO. 12,SALT LAKE CITY, KOLKATA-700091 (West Bengal)** before the date and time of opening of tender.
- Tenderer must affix seal and put address on each envelope.

TERMS & CONDITIONS

- The tenderer shall present the offer in his letter head using the enclosed offer format.
- Rate of royalty to be paid to NSC shall be quoted in Rs. Per tissue culture plant.
- The tender shall be accompanied by interest free **EMD Rs.50,000/-** , in the form of Demand Draft drawn in favour of National Seeds Corporation Ltd., Kolkata or through RTGS. Tenders without EMD may be rejected. EMD of unsuccessful tenderers except the lowest three will be returned through A/c payee cheque within 30 days of tender opening. EMD of the lowest three will be returned after the entire deal is over or within 3 months of tender opening whichever is earlier.

- In case NSC wants to sell the product of the party (Tissue Culture Plants); the party will supply the same at mutually agreed rate on priority.

- Tenders will be opened in the presence of those parties who may wish to be present. Tenders received after the due date and time may be rejected.
- The successful tenderer shall remit interest free Security Deposit of Rs. 200000 with NSC. This deposit shall be remitted within 15 days from the date of receiving the NSC's work order/intimation. EMD of the successful tenderer can be adjusted in the security amount. Failure to remit the Security Deposit will imply forfeiture of EMD.
- The successful party shall at his cost execute an Agreement with NSC on non-judicial stamp paper as per the Terms & Conditions, sign each page of the Terms & Conditions and submit the same to NSC along with the Security Deposit.
- Party's failure to arrange production and supply of plantlets as per the Terms & Conditions will entitle NSC to cancel the order, forfeiture of security and arrange production from the next party in the tender at the cost and risk of the defaulting producer.
- The party should utilize the tissue culture laboratory facilities for production of banana, bamboo and other tissue culture plants in quantity as required for their sale and pay royalty to NSC on quarterly basis based on no. of plants sold by them.
- All Inputs required for production including the protocol for production will be arranged by the party.
- The party should also take care of all the legal formalities connected to the labour and other matters associated with the production of tissue culture plant. And NSC will, in no way, be responsible for any consequence arising out of such default.
- The production will be undertaken by the party under its own supervision.
- All available infrastructure i.e. power connection, water connection, available building, green house etc. should be handed over to the party and party shall be responsible for running maintenance and operation expenses. All the bills in respect of above expenses will be paid by the party.

OTHER CONDITIONS

- The tenderer shall be responsible for observance of GST, if any.
 - At the end of the contract, the party will handover the laboratory along with other fittings etc. in good condition. In case of any damage to the permanent fixture and equipments etc. the party will make good the losses. In such case NSC may deduct the amount from the security deposit /pending payments etc. lying with NSC.
 - NSC reserves the right to accept or reject any or all the tenders without assigning any reason whatsoever.
 - Conditional offers shall not be accepted and the tenderer shall not impose any additional conditions whatsoever.
 - In the event of any question/dispute or difference arising between NSC and the supplier on any matter covered by these Terms & Conditions or arising directly or indirectly there from or connected with these Terms & Conditions in any manner, the matter shall be sorted out between the Chief Executive of NSC and the party and in the case of non-resolution of dispute the matter shall be referred to the Sole Arbitrator appointed by the Managing Director/Chairman, NSC or by any other competent officer who at the relevant time is occupying the highest office in NSC. The tenderer shall have no objection in this regard. Also the Courts of Delhi/New Delhi alone shall have jurisdiction to adjudicate thereon.
