3. **Tender shall be received on 15.12.2018 up to 15.00 hours at office of Area Manager, NSC Bhubaneswar at (Odisha) and Technical Bid shall be opened on the same day at 15.30 hours in presence of tenderer who wish to attend.**
4. The eligibility criteria for participation are given in the tender document.

5. Tenderers should be submitted both Technical bid and Price bid strictly as per instructions to tenderers given in the tender documents.
6. Tender not accompanied with requisite amount of EMD & Tender cost and not submitted as per instructions contained in the tender document are liable for rejection.

TWO BID SYSTEMS

Two independent sealed envelopes should be prepared as detailed below:

- Envelope No.1 (Sealed):- This envelope should be marked as Technical bid and should contain papers with covering letter on letter head (with name, address etc. on left side of the envelope) giving the detailed technical information and documents as required vide **ANNEXURE-II-A & ANNEXURE-II-B** of the tender document. EMD amount be kept in the sealed envelope failing which commercial bid will not be considered.
- Envelope No.2 (Sealed):- This envelope should be marked as Commercial bid and should contain rate offered by the party as detailed vide **ANNEXURE-III** of this tender.
- Both the envelopes should be inserted in one big size envelope (sealed), super scribing **“Tender for Purchase and Supply of Agriculture Implements”** – to be opened on 15.12.2018.
- The tender should be delivered in the office of Area Manager , NSC Ltd., at National Seeds Corpn Ltd., 150, Industrial Estate , Mancheswar, Bhubaneswar-751010, Odisha before the date and time of opening of tender.
- Tenderer must affix seal and put address on each envelope.

TERMS & CONDITIONS FOR SUPPLY OF AGRICULTURE IMPLEMENTS

1. Specification of Agriculture Implements to be supplied is given at **Annexure-I** of tender document.
2. EMD will be forfeited if the successful tenderer, whose rates are approved for the work, does not turn up to execute the work.
3. Tender found incomplete, conditional or without EMD/Tender Fee or without required documents and signature of authorized signatory cannot be accepted.
4. While submission of tender documents, signed copy of valid ITR's (last three years) ,GST Registration certificate and PAN Card should be submitted.
5. The rates quoted for each items should be F.O.R Sukinda farm basis.
6. The rates quoted by the tenders must be valid for 60 days from the date of opening of tenders and tenderer will have to supply the stores at the same rates to Central State Farm, Sukinda.
7. Since the items are urgently required. Hence quoted stock should be supplied within 30 days from the date of issue of supply order. The entire quantity of goods ordered will have to supply by the tenderer within stipulated time and to the entire satisfaction of the farm. In case of delay in supply of needed items liquidated demurrage will be charged from the suppliers. The items not supplied by the tenderer within the stipulated time would be purchased from other sources at the risk and cost of tenderer/supplier.

8. The materials quoted should be of best quality according to brand/quality specify in supply order. The materials will be rejected at suppliers risk and cost if found to be poor in quality/material/workman-ship specification etc. The rejection report of Farm inspecting authority shall be final & binding on the supplier.
9. 90% payment will be made after the receipt of stores in good conditions at the destination along with EMD & rest 10% payment will be paid after 90 days for conducting the trial & test satisfactory.
10. Change in terms and conditions or the specifications or schedule of completion shall not be accepted. Such conditional tenders are liable for rejection.
11. All disputes or differences in relation to the tender, the contract or the interpretation of any of their terms or implementation there-of arising out of or concerned directly or indirectly with the contract shall be referred to the Arbitration for adjudication by a Single Arbitrator to be appointed by the Chairman cum Managing Director (CMD) of the Corporation and in the absence of CMD, the highest Executive Officer of the Corporation shall make such appointment. The venue of Arbitration shall be at New Delhi. The court of law at the New Delhi/Delhi alone shall have jurisdiction in the matter to decide the disputes whatsoever.
12. The Corporation reserves the right to accept or reject any/all tenders without assigning any reason whatsoever and decision of the Corporation shall be final and binding on tenderer.
