TERMS AND CONDITIONS FOR TENDER OF NON-WOVEN CLOTH BAGS 08KG SIZE.

1-Particulars of Goods:-

(A)**Cloth:** - Printed &Stitched NON-WOVEN Cloth (NWC) bag **with handle** (NON-Laminated).

(B)**GSM of fabric:-**100 gsm.

2-Printing:-Printing with Multi Colour Offset Printing in 3 colours both side printing and ink should be offset, environment friendly sheet fed ink of Toya Company and colour shade must be uniform in all batches, sharp impressions **as per art work provided by NSC Ltd.**

3-Stitching:- Bags should be double stitched along with the top stitching and in L shape within side stitching (Inside fold) of minimum 15 MM width each side.(Top Stitching means mouth should be folded minimum 20 mm inside and stitching). The thread to be used for stitching should be 30nos. 4 ply of Madura coats/Modi/Vardhman/HP/textiles and there should be 6 stitches per inch in both side stitching as well as top stitching.

4-Tolerance: - Min. (-) 5% Tolerance in weight %., bag weight 50gm.

5-NON-Woven Bag Size: - Length 50 cm & Breadth 40cm, 08 kg capacity.

6- EARNEST MONEY & SECURITY DEPOSITS:-

The Supplier/ Company shall deposit **RS.35000/-(Rupees Thirty Five Thousand)** towards Earnest Money Deposit (EMD) at the time of submitting the tender. Upon acceptance of the tender by NSC Ltd., the successful tenderer shall also remit **Rs.85000/-(Rupees Eight Five Thousand)** only towards security deposit mandatorily within 10 days after issuing of work order by NSC Ltd. and EMD of RS.35000/- will be adjusted against security deposit.
