**GENERAL TERMS AND CONDITIONS-**

1. The bidders may inspect the car on a predetermined date and satisfy themselves about the car they are bidding for.

2. Bid letter in sealed envelope should be addressed to Manager [HR/Wel], NSC, Corporate Office, BeejBhawan, Pusa Complex, New Delhi-110012.
3. The bid must reach Tender Division, National Seeds Corporation Limited, Corporate Office, BeejBhawan, Pusa Complex, New Delhi on or before the due date. Tenders received after due date and stipulated time due to any reason whatsoever including postal delays shall not be considered.
4. The financial bid should be quoted both in figures and words along with Sales Tax if any. Any overwriting or erasing in the figures shall not be accepted.
5. National Seeds Corporation Limited reserves the right to reject bids without assigning any reason whatsoever.
6. Financial bid should be signed by the bidder[s].
7. Incomplete and unsigned bids shall be rejected.
8. Bids without EMD shall be rejected.
9. The car shall be sold to the highest bidder inclusive of Sales Tax, if any on the basis of amount quoted in the bid.
