21. Bidder will have to deposit Bank draft for Rs.25000/- (Rupees Twenty five thousand only) as earnest money for Assets/Capital items and Rs. 10000/-(Ten thousand only) for scrap/obsolete items before participation in the auction in favour of “NATIONAL SEEDS CORPORATION LIMITED, JETSAR” payable at **State Bank of India Bajuwala**. Our Bank Account No. is 33963396672 & IFSC Code SBIN0008251.
22. All the bidders / participants may submit sealed tender for all items before starting of open auction & afterwards open auction will be conducted. NSC reserves the right to obtain sealed bids or conduct re-auction for the items in respect of which the highest bid received is rejected by the disposal committee. However, in case sealed bids are to be called for, all parties having participated in the auction shall be informed or announced about the same.
23. The material is offered for bid strictly on “**AS IS WHERE IS**” basis. The Farm reserves the right to add / withdraw any lot or items before the start of the auction’s
24. All taxes such as octroi, sale tax or any other tax, if leviable by any authority up to the ultimate destination of the purchaser are payable by buyer. However, the sales certificate may be issued by the Farm, if required.
25. The Corporation / farm reserves the right of accepting or rejecting any or all the bids received & disposal of the same otherwise, without assigning any reasons to the bidders. The decision of the Corporation will be final, conclusive & legally binding to all bidders.
26. The bids will be kept open for 30 days, if necessary which can be extended up to 7 days at the discretion of the Corporation / Farm. The C.M.D of the Corporation will take the final decision of accepting or rejecting the bid received for disposal.
27. The bidder is required to deposit 25% of the total bid value at the fall of hammer. The earnest money will be adjusted towards the payment of the deposit money of 25%. The earnest money of unsuccessful bidders shall be refunded immediately after auction is over.
28. The auctioned items shall have to be removed by the purchaser / bidders within 15 days from the date of issue of letter of acceptance after depositing the balance amount in draft in favour of “**NATIONAL SEEDS CORPORATION LIMITED, JETSAR**” payable, at **State Bank Of India, Bajuwala**.
29. If the purchaser / bidder fails to deposit the amount in the due time of 15 days, amount will attract interest @ 18 % per annum for delayed period.

30. If the purchaser / bidder fails to deposit the balance amount due within a period of 30 days from the date of issue of acceptance letter, then the initial deposit of 25% of the bid may be forfeited.
31. The material is to be lifted after full payment within 30 days of issue of acceptance letter, after which ground rent @ Rs.10.00 per day per lot will be charged.
32. The material has to be lifted in any case within 60 days of issue of acceptance letter, i.e., ground rent can be paid up to maximum 30 days.
33. If the purchaser / bidder fails to lift the material within a period of 60 days of issue of acceptance letter, then the C.M.D. / Director reserves the right to auction or dispose off the earlier auctioned goods in a manner he deems proper & fit, at the risk & responsibility of previous bidder / purchaser.
34. The delivery of the auctioned material will be given on working day during working hours.
35. If the purchaser / bidder intends to take delivery of auctioned material through his representative, he should give the letter of authority duly countersigned by competent authority.
36. The Corporation will not take any responsibility for arranging export permit, transport and wagon etc. to purchaser / bidder.
37. In the event of infringement of any terms & conditions by the purchaser / bidder, the Corporation / Farm at his discretion may forfeit the earnest money & deposit made by the purchaser / bidder.
38. If the purchaser / bidder is found trying to negotiate with any Corporation / Farm employees for any undue benefit, whatever the reason may be, he will be debarred from participating in auction & deposits made by the purchaser / bidder will be forfeited.
39. The disputes / differences which may arise between the disposal committee & purchaser / bidder or their representatives, shall be referred to the C.M.D of the Corporation and the decision of C.M.D will be final, conclusive & binding on both parties.
