TERMS AND CONDITION OF TENDER –CUM – AUCTION FOR SALE OF UNSERVICEABLE ACHINERY, AGRICULTURAL IMPLEMENT & OBSOLETE MATERIAL ETC.

1. Bidders will have to deposit Rs. 25000/- (Rupees Twenty Five Thousand Only) for capital items and Rs. 10000/- (Rupees Ten Thousand Only) for Scrap martial as earnest money separately before participation in the tender cum auction.
2. All the bidders participants will have to submit sealed tender for all items before starting of open auction and after wards open auction will be conducted. The corporation reserves the right to obtain sealed bids or conduct re-auction for any items for which the highest bid received by the disposal committee. However in case sealed bids are to be called for, all parties having participated in the auction shall be informed or announced about the same.
3. The material is offered for bid strictly on “**AS IS WHERE IS BASIS**” the farm reserves to right to add/withdraw any lots or items before the start of the auction. In addition to above, quantity can also be increase/ decreased as per availability.
4. All taxes such as octroi, sales tax or any other tax, if livable by any authority up to the ultimate destination of the purchaser, are payable by buyer. However, the sales certificate may be issued by the farm if required.
5. The Corporation/Farm reserve the right of accepting or rejecting any or all the bids received without assigning any reasons to the bidders. The decision of the Corporation will be final conclusive and legally binding to all bidders.
6. The bids/rates will be kept open/valid for 30 days, if necessary which can be extended up to 7 days at the discretion of the Corporation/ Farm. The Chairman–cum–Managing Director of the Corporation will take the final decision of accepting or rejecting the bid received for disposal. In case decision is kept pending the party has to deposit 25 % of the bid amount which will be retained up to the date of receipt of approval from the Head Office without attracting any interest.
