(1). ACCESSING / PURCHASING OF BID DOCUMENTS:

It is mandatory for all the bidders to have Class-III Digital Signature Certificate (With Both DSC Components, i.e. Signing & Encryption) from any of the licensed Certifying Agency (Bidders can see the list of licensed CA's from the link www.cca.gov.in) to participate in e-tendering of NSCL.

ADVICE FOR BIDDERS:

The Bidders are advised in their own interest to carefully read the tender documents and understand their purport unless the Bidder specifically states to the contrary in respect of any particular clause, it shall be presumed that they accept all the terms and conditions as have been laid down in tender document.

Tender Fee(Non-Refundable): Tender fee Rs 100/- (Rupees One Hundred only) must be deposited in online mode only (As per instruction in Section-I).

Earnest Money Deposit (Refundable): EMD amount 10,000/- (Rupees ten Thousand only) must be deposited before due in online mode only (As per instruction in Section-I). Exemption of EMD for Indian Manufactures which are registered with NSIC under Single point registration scheme, Indian manufactures / suppliers who are Micro and Small Enterprises (MSE) small scale units and registered with National Small Industries Corporation (NSIC) under single point registration scheme are exempted from payment of EMD provided to furnish photocopy of valid registration with NSIC under the single point registration scheme for the quoted stores in support if claim along with their requested letter. BID OPENING AND EVALUATION: Bids will be open in Online Mode (As per instruction in Section-I).

AWARD OF CONTRACT: The technical bid will open first and based on the information committee will scrutinise the bid submitted and evolve the successful bidder for financial bid. Purchase / sale committee will award the Contract to the successful Bidder whose bid has been determined to be substantially responsive and has been determined as the best evaluated bid provided further that the Bidder is determined to be qualified to perform the Contract satisfactorily, for which the Firm may be asked for making a presentation, along with other parameters.

TREMS & CONDITIONS FOR PROCESSING AND PACKING OF SEEDS

The farm invites tenders from reputed contractors for processing and packing of seeds with the terms and conditions indicated below.

1. Before participating in the tender, the bidders will have to deposit a sum of Rs.10,000/- As security Money through online in favour of “National Seeds Corporation Ltd” payable at Sindhanur. The Security money of unsuccessful bidders will be returned within two week time.
2. The contract will be of one year duration which can be extended for 6 months/1 Year with same terms& condition at the discretion of the Competent Authority.
3. The prospective contractor should be registered with the Karnataka state/central Government and should have substantial experience in various aspects of labour licence, etc.
4. The contractor will have to pay service tax/income tax and any other tax which are applicable as per rules and submit the details to the office
5. The contractor will not be allowed to sub-let the contract.
6. The contractor has to execute agreement on Rs.100/- stamp paper after receipt of work order from the Farm. The cost of stamp paper has to be borne by the party.
7. The contractor shall undertake the responsibility for providing adequate labourers **for processing & loading- unloading, stacking of seed / raw seed** and finishing the work well in time as is desired by the Corporation. The contractor shall not be eligible for giving, sub-contract. He will be responsible to make losses good due to the fault of labours, intentional or ignorly provided by contractor and will be recovered from his running bill or from security deposit. In the event of loss incurred to NSC Ltd exceeding the amount of security deposit and the bills, which may be payable or may become payable to the contractor, the contractor shall be under an obligation to pay that amount on demand within a week time.
8. All the work shall be attended on “to be billed”, basis and the payment will be made after expire of the month, All such like bills are got to be verified from the concerned plant I/c. Labour contractor is required to submit printed serially numbered bills indicating full details of works done during the month. Only one bill, after expire of month, is required to be submitted and no part payment during the month shall be allowed.
9. The contractor shall provide necessary labour immediately, on demand given by NSC Ltd to the contractor, even on the telephone or otherwise. In the event of failure of the contractor to provide the desired labourers, it will open to NSC Ltd to arrange labourers at the cost of contractor and in the event of NSC Ltd being obliged to pay to such labourers, the amount paid shall become recoverable from the contractor with whom

the agreement has been entered. The payment made by the NSC Ltd and the same will be deductible from the bills of the Contractor. Labourers engaged by the Corporation shall be conclusive evidence of the amount paid and contractor shall not dispute the correctness of the same and contractor shall be under obligation to pay the same either in cash or through recovery/adjustment from the amount at the credit of the contractor.

10. Contractor will have to take care of his/he labours and provide all necessary tools/gloves/other safety equipment on his/her cost to the labours.

11. Contractor should always keep the premises clean before and after the packing/processing. No extra labour charges would be made to him for the above job.

ARBITRATION CLAUSE:

Any dispute arising out of this contract between the parties here to or/and their representatives or assignees shall be referred for the Arbitration to the Chairman cum Managing Director, NSCLtd, New Delhi or his nominee. His or his nominee will be the sole Arbitrator and whose decision shall be final conclusive and binding on both the parties.
