- It is mandatory for all the bidders to have Class-III Digital Signature Certificate (With Both DSC Components, i.e. Signing & Encryption) from any of the licensed Certifying Agency under CCA, Ministry of Electronics and Information Technology, Government of India to participate in e-tendering portal of NSCL. Earnest Money Deposit (Refundable): EMD amount 8000/- (Rupees Eight Thousand only) must be deposited before due in online mode only (As per instruction in Section-I). TERMS AND CONDITIONS

1. Price quoted should be inclusive of all taxes.
2. The chemical should be supplied immediately on receipt of the supply order.
3. It is requested and agreed by the supplier that 3 joint samples will be drawn after receiving at the farm in presence of the representative of supplier(if desired by the party). One set sample will retain by the supplier and the purchaser and third will be for analysis.
4. The payment will be released immediately after receipt of satisfactory analytical report from the laboratory.
5. In case if the chemical is not meet the standard, the same has to be taken back by party on own cost. The testing charges are to be borne by the farm.
6. The price should be quoted in accordance with the packing size i.e. 20, 5 and 1 ltr/Kg and also by indicating the company name; however we prefer bigger & economical packing. **Rates quoted are valid for one month.**
7. Validity of chemical should be minimum one year.
8. Material supplied should be maximum two lots, beyond two lots the testing charges is to be borne by the party.
