2. **E-Tender for Disposal of Condemned Processing Plant Machines and Equipments at Baliapur(“As is Where is Basis”)**.
3. Online Tenders will be accepted upto **03.08.2020 till 14:00 Hrs.** Technical bid will be opened on the **same day at 15:00 Hrs.** and Financial bid of the technically qualified tenderers will be open thereafter..
4. Tender Form cost of Rs. 1180/- (One thousand one hundred eighty rupees only) against cost of Tender Form, (Non-refundable) will be deposited through online mode only i.e, internet banking, Debit Card, Credit Card etc.
5. The tenderer shall submit **Rs. 10,000/- (Ten thousand only)** towards **Earnest Money Deposit** at the time of submitting the Tender. The payment of EMD (Rs.10,000/-) shall be made by online mode . EMD deposited by the successful tenderer will be retained by the Corporation till the entire deal is completed satisfactorily. The EMD will be refunded without interest after completion of the lifting of condemned machines and equipments as per the order.
6. Micro and small Enterprises which is registered with NSIC under SPRS (Single point Registration Scheme) as specified by Ministry of Micro, Small and Medium Enterprises (MSME) with two years validity certificate as on date duly issued by NSIC are exempted for submitting the tender fee and earnest money deposit provided exemption for same have been indicated in the certificate. No other type of certificate is acceptable. The exemption and relaxation of tender fee and EMD is subject to the validity & acceptance of their registration certificate on the date of opening of tender.

8. The EMD of the unsuccessful tenderers will be refunded through RTGS/NEFT on the request of the tenderer with proper supporting documents (**only after completion of tender work**)
9. The condemned machines & equipments to be segregated and lifted by the purchaser at his own cost. The machines and equipments are offered for bid strictly on “**AS IS WHERE IS BASIS**”.
10. The condemned machines and equipments can be inspected between 10.00 AM to 5.00 PM on all working days at CSF, Baliapur.
11. The successful tenderer have to deposit 25 % cost of the condemned machines and equipments, as mentioned above, within 3 days from the date of issue of delivery order from NSC. The above condemned machines and equipments will be lifted by the party within 30 days from the date of issue of delivery order after making the balance payment and the deposit of 25 % paid by the party will be adjusted in final and last lifting of the material.
12. In case the successful tenderer fails to deposit corresponding amount or fail to lift the condemned machines and equipments within the 30 days from date of issue of delivery order, the Corporation reserves the right to cancel their tender and to forfeit the EMD and other all deposits paid by them.
13. The tenderer must thoroughly inspect the quality of condemned machines and equipments before submission of the tender (Located at **Baliapur, Dhanbad-828201**). Request for variation of rates will not be considered under any circumstances after opening of the tenders.
14. The tenderer must quote their rate for total quantity available with NSC of a particular item & the H-1 party has to lift all the quantity of that particular item.
15. All Taxes such as G.S.T. or any other applicable on condemned machines and equipments, if Leviable by any Authority up to ultimate destination of the tenderer are payable by successful tenderer only. **So, rates be quoted without GST & any other tax and these taxes will be paid at the time of disposal (Whatever rates is applicable).**
16. The rates quoted by the party should remain valid for 90 days from the date of opening of the tender.
17. Quantities mentioned in the tender notice may increase or decrease at the time of delivery (Lifting).
18. In the event of any difference or disputes arising out of or in connection with agreement the same shall be referred to the sole arbitrator to be nominated by the Chairman & Managing Director of NSC Ltd. On application, being made to him either of the parties and shall agree that there shall be no objection to such person being in any manner connected with NSC Ltd. or Govt. of India undertaking. The arbitrator so appointed shall have the power to determine his own procedure and shall make an award which shall be final and binding on the parties.
