## TERMS & CONDITIONS

1. The Tenderer should thoroughly go through the terms & conditions before submitting the tender.
2. Sealed tender to be submitted in the prescribed format, separately for technical & financial bids with envelopes super scribed as “**Technical bid**” and “**Financial bid**” respectively over envelope and both the sealed bids should further be sealed in another envelope super scribed as “**Tender for Disposal of Condemned Processing Plant Machines and Equipments at Aurangabad (“As is Where is Basis”)**”.
3. Tenders in sealed envelope will be accepted at **National Seeds Corporation Ltd, F-8/2, MIDC Area, Naregaon Road Chikhalthana, Aurangabad-431210** upto **30-07-2020 till 13:30 Hrs.** Technical bid will be opened on the **same day at 14:30 Hrs.** and Financial bid of the technically qualified tenderer will be open thereafter. The decision of the committee will be communicated to successful tenderer either telephonically/in writing within a period of 90 days.
4. Tenderers should submit original current affidavit (issued after 09-07-2020) duly Notarized, stating that their firm has been neither BLACK LISTED by any Government / Other Agencies nor having any relation / co-relation directly or indirectly with the employees/Dealers of NSC.
5. The cost of tender form is **Rs. 590/- (inclusive of 18% GST) (Non-refundable)**. Tender should be attached with EMD & Tender fee. Tender Form can be purchased by paying Cash of Rs. 590/- (inclusive of 18% GST) from National Seeds Corporation Ltd., F-8/2, MIDC Area, Naregaon Road Chikhalthana, Aurangabad-431210 on all working day from 09-07-2020 (13:00 AM to 17:00PM) or Tender Form can be downloaded from NSC website [www.indiaseeds.com](http://www.indiaseeds.com). Any Tender Form downloaded from NSC website [www.indiaseeds.com](http://www.indiaseeds.com) should be attached with DD of Rs. 590/- (Five hundred ninety rupees only) against cost of Tender Form, Non-refundable drawn in favour of National Seeds Corporation Ltd. payable at Pune or **transfer to NSC SBI Account No.32919549520 IFSC Code SBIN0006117 Branch Market Yard, Pune.**
6. The tenderer shall submit **Rs. 10,000/- (Ten thousand only)** towards **Earnest Money Deposit** at the time of submitting the tender Tender. The payment of EMD (Rs.10,000/-) shall be made by **Demand Draft drawn in favour of National Seeds Corporation Ltd, payable at Pune or transfer to NSC SBI Account No.32919549520 IFSC Code SBIN0006117 Branch Market Yard, Pune.** EMD deposited by the successful tenderer will be retained by the Corporation till the entire deal is completed satisfactorily. The EMD will be refunded without interest after completion of the lifting of condemned machines and equipments as per the order.
7. Micro and small Enterprises which is registered with NSIC under SPRS (Single point Registration Scheme) as specified by Ministry of Micro, Small and Medium Enterprises (MoMSME) with two years validity certificate as on date duly issued by NSIC are exempted for submitting the tender fee and earnest money deposit provided exemption for same have been indicated in the certificate. No other type of certificate is acceptable. The exemption and relaxation of tender fee and EMD is subject to the validity & acceptance of their registration certificate on the date of opening of tender. The firm has to submit a request letter for exemption of tender cost & EMD. This facility

however, will not be provided to those parties who are registered under the old registration schemes which were extended upto 30<sup>th</sup> June, 1981.

8. The EMD of the unsuccessful tenderers will be returned online on the request of the tenderer.
9. Tenders downloaded from website should be accompanied with the undertaking given by the tenderer that he/she/they has/have not made any alteration/change in the downloaded term & condition of the tender. If any alteration/change is found in the term & condition during the process of Tender/during the period of Contract (if awarded any) will be out rightly cancelled without giving any notice.
10. The condemned machines & equipments to be segregated and lifted by the purchaser at his own cost. The machines and equipments are offered for bid strictly on **“AS IS WHERE IS BASIS”**.
11. The condemned machines and equipments can be inspected between 10.00 AM to 5.00 PM on all working days at NSC, Aurangabad.
12. The successful tenderer have to deposit 25 % cost of the condemned machines and equipments, as mentioned above, within 3 days from the date of issue of delivery order from NSC. The above condemned machines and equipments will be lifted by the party within 30 days from the date of issue of delivery order after making the balance payment of 75 % before lifting any items.
13. In case the successful tenderer fails to deposit corresponding amount or fail to lift the condemned machines and equipments within the 30 days from date of issue of delivery order, the Corporation reserves the right to cancel their tender and to forfeit the EMD and other all deposits paid by them.
14. The tenderer must thoroughly inspect the quality of condemned machines and equipments before submission of the tender. Request for variation of rates will not be considered under any circumstances after opening of the tenders.
15. The tenderer must quote their rate for total quantity available with NSC of a particular item & the H-1 party has to lift all the quantity of that particular item.
16. All Taxes such as G.S.T. or any other taxes applicable on condemned machines and equipments, if Leviable by any Authority up to ultimate destination of the tenderer are payable by successful tenderer only.
17. The rates quoted by the party should remain valid for 90 days from the date of opening of the tender.
18. Quantities mentioned in the tender notice may increase or decrease at the time of delivery (Lifting).
19. In the event of any difference or disputes arising out of or in connection with agreement the same shall be referred to the sole arbitrator to be nominated by the Chairman & Managing Director of NSC Ltd. On application, being made to him either of the parties and shall agree that there shall be no objection to such person being in any manner connected with NSC Ltd. or Govt. of India undertaking. The arbitrator so appointed shall have the power to determine his own procedure and shall make an award which shall be final and binding on the parties.

- 20. In confirmation of acceptance of the Tender terms and condition, the tenderer is required to sign on all the pages of the tender document with seal and submit the same along with **Technical bid**.
- 21. The Regional Manager reserves the right to accept or reject the tender in part or in whole without assigning any reason whatsoever.
- 22. In the event of Violation of any of the terms & condition by the tenderer, the corporation at its own discretion may forfeit the EMD/any other deposit made by tenderer.
- 23. The party/tenderer has to submit his PAN and residential proof/Adhar card before lifting the materials.
