

The Tender shall be opened on 25.01.2021 at 03.00 PM in presence of the tenderers, who may like to be present in the Office of the Director. Envelope containing tender documents should be duly super scribed as **tender for supply of 5 Nos. Screw Pump due on 25.01.2021. The Tenderers must be having GST No., otherwise tender will not be considered.**

- 1 Tender received after due date and time shall not be accepted
- 2 The tender should be submitted either in typed form or clearly hand writing. Any cutting or overwriting be signed by tenderers. Tenderers should be GST Holder.
- 3 The rate quoted for each items should be F.O.R. Sardargarh farm only.
- 4 Farm will not supply any form 'D' or "C "and applicable rates of Tax shall be charged.
- 5 The rates quoted by the tenderers must be valid for 60 days from the date of opening the tender and tenderers will have to supply the Implements at the same rates to Central State Farm, Sardargarh, if order placed during the period of 60 days
- 6 Since the materials are urgently required, these should be quoted from ready stocks of which can be arranged maximum within 15 days from the date of issue of supply order. The ordered materials will have to be supplied by the tenderers within the stipulated time and to the entire satisfaction of the farm. In case of delay in supply, than, liquidated demurrages as applicable may be charged from the suppliers. The requisite materials not supplied by the tenderers within the stipulated time would be purchased from other sources at the cost of tender/suppliers.
- 7 The materials supplied should be strictly as per the specification. Any deviation from specification will be liable for rejection.

- 8 The materials quoted should be of best quality and will be object to rejection at suppliers risk and cost, if found to be poor in quality/materials. Workmanship/specification etc. The rejection report of farm inspecting authority shall be binding on the supplier.
- 9 90% payment of required items will be made within 10 days after the receipt of materials in good condition at the farm and rest 10 % after satisfactory test and trial of the machine within one month.
- 10 The Director of farm reserve the right to reject the tender completely or part their off without assigning any reason.
- 11 In the event of any dispute arising amongst the tenderers, the parties agree to use their efforts to attempt to resolve all disputes in prompt, equitable and good faith. In the event the parties are unable to do so, then such dispute is finally resolved by arbitration. The arbitration shall be conducted in the English language and the venue of the arbitration shall be in New Delhi. The sole arbitrator will be appointed by CMD, NSC Ltd. whose decision in this regard will be final & binding.
