INSTRUCTIONS TO BIDDER – ONLINE MODE

DEFINITIONS:

- **C1 India Private Limited:** Service provider to provide the e-Tendering Software.
- **NSCL e-Procurement Portal:** An e-tendering portal of National Seeds Corporation Limited (“NSCL”) introduced for the process of e-tendering which can be accessed on <https://indiaseeds.eproc.in>.

I. ACCESSING / PURCHASING OF BID DOCUMENTS :

- It is mandatory for all the bidders to have Class-III Digital Signature Certificate (With Both DSC Components, i.e. Signing & Encryption) from any of the licensed Certifying Agency under CCA, Ministry of Electronics and Information Technology, Government of India to participate in e-tendering portal of NSCL. Bidders can see the list of licensed CA’s from the link www.cca.gov.in C1 India Pvt. Ltd. also facilitate Class III Digital Signature Certificate (With Both DSC Components, i.e. Signing & Encryption) to the bidders. Bidder may contact C1 India Pvt. - To participate in the e-bid, it is mandatory for the Applicants to get themselves registered with the NSCL e-Tendering Portal (<https://indiaseeds.eproc.in>) to have a user ID & Password which has to be obtained by submitting a non-refundable annual registration charges of Rs. 3416/- inclusive of all taxes through **online** mode. Validity of Registration is 1 year.
- The amendments / clarifications to the tender, if any, will be posted on the NSCL e-Tendering Portal (<https://indiaseeds.eproc.in>).
- To participate in bidding, bidders have to pay EMD (refundable) as per the amount mentioned in the tender document online through NEFT/RTGS after generating E-challan from <https://indiaseeds.eproc.in>.
- To participate in bidding, bidders have to pay Tender Processing Fee of Rs. 570/- inclusive of all taxes (Non-refundable) through online mode (internet banking/debit card/credit card).
- The Bidder may modify or withdraw their bid after submission prior to the Bid Due Date. No Bid shall be modified or withdrawn by the Bidder after the Bid Due Date and Time.

Terms and conditions:

1. Last date of tender submission is 15.02.2021 (13:00 hours) and technical and financial bid will be opened on the same date at 02:00 PM and 3.00 P.M. respectively
2. The supplier should quote the model/make/brand/warranty of items offered by them as per the specifications mentioned; else the bid may be rejected.
3. Rates should be quoted F.O.R. Jetsar Farm and the rates should be including GST, packing & forwarding charges, transportation charges & transit insurance charges etc. These charges shall be shown separately.
4. The supply is required within 15 days after placing the supply order.
5. The offer must be valid for a period of one month from the date of opening of tender.
6. The payment of the bill will be made within 30 days after supply of the material in good condition subject to submission of appropriate bill.
7. Tenders not received in accordance with the above mentioned terms & conditions are likely to be rejected.
8. On the basis of tender received, if the firm does not supply the material ordered within stipulated delivery period the purchases would be made from the alternative sources at risk & cost of the firm and liquidated damage of the farm would be recovered from the defaulter firm.
9. The right to reject & accept any or all the tenders without assigning any reason is reserved with Head of Farm.
