### **Terms and conditions for sale of Non Seed**

- 1 The EMD amount Rs. 10000/- and tender form fee Rs. 100/- along with GST and other taxes, should be deposited by the tenderer via RTGS/NEFT/DD for participating in the open tender. The EMD of unsuccessful bidder will be returned within a week without any interest on such amount. The EMD of successful bidders will be converted into security deposits which will be returned without any interest, after successful completion of work.
- 2 Two bid system will be followed, technical bid and financial bid should be covered separately over duly sealed super-scribed as “Tender for sale of substandard seed as Non Seed (Technical Bid/ Financial Bid) ” and addressed to the Area Manager, NSCL Jalandhar (144004).
- 3 Bids received within the due date and time only will be entertained.
- 4 Bidder cannot withdraw their offer once it is submitted to NSC.
- 5 Bids are collected till 01:00 PM on due date and opened at 2:00 PM on the same date.
- 6 The successful tenderer shall have to deposit whole amount at once before issue of work order within three working days from opening of bid via RTGS/NEFT/DD along with GST and other taxes, if any.
- 7 EMD of the successful bidder will be refunded after 30 days from opening of bid.
- 8 A copy of *Pan Card, Aadhar Card & GST Number* should be enclosed along with tender form.
- 9 The cost of collection, loading & transportation etc. will be completely borne by tenderer only.
- 10 The loaded tractor/ truck should carry a *Gate Pass* issued by the concerned *I/C*.
- 11 The gate pass shall be signed either by contractor himself or the authorized person.
- 12 The work of seed lifting by the successful bidder shall be completed within 5 working days from date of issuance of work order on working days between **10.00 AM to 5.30 PM** only.
- 13 **Any taxes will be borne by the party.**
- 14 All types of statutory liability will be with the bidder.
- 15 NSC reserves the right to accept or reject any/all tenders without assigning any reason whatsoever.
- 16 The non seed offered for sale through Open Tender is strictly on “**AS IS, WHERE IS BASIS**”. NSC reserves the right to include or exclude any quantity before the commencement of the Tender.
- 17 In case any dispute arises between NSC and the other party due to any term or matter, both the parties will opt to resolve it through mutual understanding and discussion. In case, dispute remains even after discussions, then it shall be binding upon parties to resolve issue under the provisions of Arbitration & Conciliation Act, 1996 as amended from time to time. Under this provision, the Chairman-cum- Managing Director, National Seeds Corporation Limited with the concurrence of both the parties shall appoint Sole Arbitrator to resolve the issue and both the parties will have to abide by the decision. The parties will bind to resolve this dispute through arbitration before going to court of law. The Arbitration shall be conducted at New Delhi and shall in English Language. The court of Delhi shall have the jurisdiction.
