The Tenders duly sealed along with Demand Draft in favour of National Seeds Corporation Ltd. payable at Hyderabad (for EMD & cost of tender) should be submitted up to **12.30 Hrs. on 20.04.2021 at Regional Office, National seeds Corporation Limited, 17-11 Tukaram Gate North Lalaguda, Secunderabad-500017.**

The cost of tender & EMD can also be transfer to NSC SBI Account No. **32897527652 IFSC Code SBIN0020822 Branch, Malkajgiri (West), Secunderabad/Hyderabad.** The Tenders so received shall be opened by the Committee on the same day i.e. on 20.04.2021 at 13.00 Hrs. in the presence of Tenderers / their representatives at Regional Office, Secunderabad (if be present) and after the evolution of Bids, the Open auction shall be conducted if required.

2. The Tender should be submitted only after agreeing with all the terms and conditions. For acceptance of terms and conditions. The Tender in **Two Bid System:**

Two independent sealed envelopes should be prepared as detailed below:

6. Financial Bid should contain only the offered rate in the provided format and all other details/documents should only be mentioned/attached with **Technical bid only.**
7. Opening of Applications will be done through by the Tender Committee at Regional Office, Secunderabad. The bidder may present in opening of the tender, however, no invitation shall be given.
8. NSCL shall open documents of the Application received in sealed envelope only. NSCL will subsequently examine and evaluate the Applications in accordance with the provisions set out in the NIT.
9. The price bid of the eligible applicants only will be opened and the date of opening of price bid will be notified later on.

1. The items can be inspected at our office between 2.00 P.M. to 4.00 P.M. [Monday to Saturday except Second Saturday & public holidays] on all working days till the last date for the receipt of tender.
2. Interested Parties may submit their sealed tenders after inspection of the items in our premises at 17-11, TukaRam Gate north Lalaguda, Secunderabad-500017.
3. The sale shall be on **'As is where is basis" and No Weighment/Count Basis.**
4. It is the responsibility of the bidder to assess the items properly before quoting. No further claims will be entertained after opening of the bids.
5. All the Tenders shall be prepared as per the prescribed format and submitted in accordance with instructions in the tender document and the offer must be accompanied by EMD of Rs. 2000.00/- (Refundable) (Rupees Two Thousand Only) by Demand Draft / Pay Order in favour of "National Seeds Corporation Limited." Offer without EMD shall not be considered. The EMD shall bear no interest.
6. Any correction or alteration is not allowed in the Financial Bid.
7. All Taxes and Duties to be paid extra, as applicable, at the time of lifting the materials and if any amount found recoverable on account of revision of tax, or any other statutory duties levied by Central or State Govt. at a later stage will be payable by the purchaser.
8. The rates quoted by the bidder through sealed cover and through open auction, whichever the rate is higher shall be considered as **bid value.**

10. The Bidder selected [H-1] to lift the scrap items will have to deposit advance @ 10% of the total value of the items within 3 days from the issue of order or acceptance of rates.
11. The bidder selected for lifting the scrap items from the premises of NSC shall have to lift within 15 Days from NSC premise on depositing remaining balance of 90% of the amount of the scrap items.
12. EMD of unsuccessful bidder will be returned after 30 days from opening of the bid.
13. EMD of the successful bidder will be refunded after completion of the contract OR may be adjusted in the final 90% payments of the bidder.
14. In case the bidder fails to pay the 10 % amount in advance within 3 days of receipt of sale order, his EMD is liable to be forfeited and his bid will be cancelled.
15. The bidder will not be permitted to sort out the materials. The entire lot should be cleared as directed by the officer in charge.
16. Removal and transportation of materials shall be done only during working hours of NSC. No materials will be allowed to be lifted after 5:30 PM on week days. Similarly, no materials will be allowed to be lifted on Saturdays, Sundays and Holidays.
