### ADVICE FOR BIDDERS:

The Bidders are advised in their own interest to carefully read the tender documents and understand their purpose unless the Bidder specifically states to the contrary in respect of any particular clause, it shall be presumed that they accept all the terms and conditions as have been laid down in tender document.

**Tender Cost (Non-Refundable):** Tender cost Rs 590/- (Rupees five hundred and ninety only) (Including GST) must be paid in online/ Offline mode.

### **Earnest Money Deposit (Refundable):**

The EMD of 25000.00 (Twenty Five thousand rupees only) should be deposited by the tenderer for participating in the tender as mentioned in the tender notice No. NSC/CSF/JWL/Prodn./4(29)/2023-24. Dated 02.01.2024 and must be paid before due date in online mode only.

**Eligibility Criteria:** Any person having valid *Pan Card, Aadhar Card & Voter ID* and Bank Account will be eligible.

**Submission of Offer:** Offer must be submitted in prescribed tender input form in Offline Mode only. Only that party should tender who accepts all the terms & conditions because conditional tender may be treated as void.

**BID OPENING AND EVALUATION:** Bids will be open in offline Mode (As per instruction in Section-B).

**AWARD OF CONTRACT:** The technical bid will open first and based on the technical bid the committee will scrutinize the bid submitted and evolve the successful bidder for financial bid. The committee will award the Contract to the successful Bidder whose bid has been determined to be substantially responsive and has been determined as the best evaluated bid provided further that the Bidder is determined to be qualified to perform the Contract satisfactorily, for which the Firm may be asked for making a presentation, along with other parameters

**Notification of award:** Prior to the expiration of the period of bid validity the Committee will place a firm order or notify the successful Bidder in writing.

**Cancellation of Work order:** NSC reserves the right to cancel the contract at any stage (by giving the notice in writing) due to non-satisfactory services of the selected firm/party.

### **Terms and conditions for grazing of sheeps/goats at the Central State Farm, Jawalagera.**

1. The prospective tenderers shall have to deposit 25,000 as EMD. The EMD should be furnished in the form of Insurance Surety Bonds or can be deposited in the form of NEFT/RTGS/UPI & DD/ drawn in favour of “NATIONAL SEEDS CORPORATION LIMITED” on any authorized Bank payable at Sindhanur or UPI/ NEFT/RTGS/Bank Deposit to this **Bank - STATE BANK OF INDIA, A/c Name- NATIONAL SEEDS CORPORATION LIMITED A/c No.- 34019001808 IFSC Code- SBIN0007861.** The EMD of successful tenderer shall be converted into Security Deposits while that of the unsuccessful tenderer shall be refunded through cheque within a week without any interest on such amount. SD will be returned without any interest on satisfactory completion of grazing period. Security deposit will be liable to be forfeited in case of loss of farm/property on valuation of any term & condition.
2. The successful bidder will have to deposit 30 percent of the total amount of grazing charge within 3 day of tender and 70 percent in 7 days of the tender. If 30 percent of the total amount of grazing charge is not deposited within 3 days of tender, the security deposits will be forfeited.
3. The grazing time will be 60 days after issuing permit and will be able to graze only in the jungle area of chak 12 (350.00 acres).
4. If there is any damage to the farm property/ Crops, it will be recovered from the concerned contractor.
5. Contractor or grazers will not bring any type of weapons in the farm area during grazing period. After the allotment of grazing contract, the contractor will be responsible for preventing illegal grazing. The farm will not be responsible for this.
6. During the grazing period, if any jungle is uprooted then no area in compensation will be given. In case of any damage to the sown crops, the permit will be cancelled.
7. A permit will be issued by the competent authority for grazing, only then grazing will be allowed.
8. Always show a permit on demand of any officer of the farm, security watchman, and Unit/chak in-charge. Grazing will be considered illegal if found grazing of animals without a permit.
9. Grazing can be stopped by the Farm Director without giving any reason if found to be involved in wrong activities.
10. The grazers shall be allowed grazing in defined area (jungle area in chak 12) only for which defined area will be earmarked. They cannot be moved in the other farm area/ units/ chaks without permission of security guard and concerned chak incharges. During grazing, the sheeps/goats will not go from one area to another for water. If sheeps/ goats etc. dies or any damage occurred to the sheep as well as owner during the period of grazing, the farm will not be responsible for it.
11. Successful bidder have to enter into a contract on a non-judicial stamp Rs. 100 that will not cause any damage to the crops of the farm and will graze their animals in the area where the permit is taken and follow the terms and conditions of the tender.
12. All types of statutory liability will be with the contractor.

13. The Farm Director reserves the right to accept or reject any/all tenders without assigning any reason whatsoever and decision of the Farm Director shall be final and binding on tenderer.

### **ARBITRATIONS**

In case of any dispute arises between NSC and the other party due to any term or matter, both the parties will opt to resolve it through mutual understanding and discussion. In case, dispute remains even after discussions, then it shall be binding upon parties to resolve issue under the provisions of Arbitration and Conciliation act 1996 as amended from time to time. Under this provision, the Chairman-cum- Managing Director, National Seeds Corporation Limited with the concurrence of both the parties shall appoint Sole Arbitrator to resolve the issue and both the parties will have to abide by the decision. The parties will bind to resolve the dispute through arbitration before going to court of law. The Arbitration shall be conducted at New Delhi and shall be in English Language. The Court of Delhi shall have the Sub jurisdiction
