GENERAL TERMS AND CONDITIONS FOR AUCTION OF OBSOLETE VEHICLE

1. Bidders will have to deposit Rs. 1500/- (Rupees One Thousand Five Hundred Only) as earnest money separately before participation in the tender cum auction.
2. Interested Parties may submit their tenders after inspection of the items in our premises at Regional Office – Chandigarh, National Seeds Corporation Limited, Plot No. 24, Industrial Area Phase-IX, Mohali, Chandigarh – 160062 (PUNJAB). The inspection of the premises can be made between 11.00 A.M. to 4.00 P.M. on all working days till the last date for the receipt of tender, except on Second Saturday, Sunday and public holidays.
3. The material is offered for bid strictly on "AS IS WHERE IS BASIS" the office reserves to right to add/withdraw any lots or items before the start of the auction. In addition to above, quantity can also be increase/ decreased as per availability.
4. All taxes such as octroi, sales tax or any other tax, if leviable by any authority up to the ultimate destination of the purchaser, are payable by buyer. However, the sales certificate may be issued by the office if required.
5. The Corporation/office reserve the right of accepting or rejecting any or all the bids received without assigning any reasons to the bidders. The decision of the Corporation will be final conclusive and legally binding to all bidders.
6. The bids/rates will be kept open/valid for 30 days, if necessary which can be extended up to 7 days at the discretion of the Corporation/ office. The Chairman-cum-Managing Director of the Corporation will take the final decision of accepting or rejecting the bid received for disposal.
7. The Earnest Money Deposit [EMD] of the successful bidder shall be adjusted in the bid amount. The EMD of unsuccessful bidder shall be returned within one month of the auction date without any interest.
8. The material is to be lifted after full payment within 30 days of issue of acceptance letter, after which ground rent @ Rs. 25/- per day will be charged.
9. If the purchaser/bidder fails to deposit the balance amount due within a period of 30 days from the date of issue of acceptance letter, then the corporation/office will forfeit the deposited EMD amount by the bidder.

If any dispute/difference/disagreement arise between the parties and unable to settle mutually may be referred to the sole arbitration to the Chairman Cum Managing Director of National Seeds Corporation Limited or other person appointed by the CMD, as arbitrator and their decision will be final which will be acceptable by both parties. However, in case of legal aid, New Delhi court is only the jurisdiction.

SETTLEMENT OF DISPUTES:

In case any dispute arises between NSC and the other party due to any term or matter, both the parties will opt to resolve it through mutual understanding and discussion. In case, dispute remains even after discussions, then it shall be binding upon parties to resolve issue under the provisions of Arbitration and Conciliation act 1996 as amended from time to time. Under this provision, the Chairman-cum-Managing Director, National Seeds Corporation with the concurrence of both the parties shall appoint Sole Arbitrator to resolve the issue and both the parties will have to abide by the decision. The

parties will bind to resolve this dispute through arbitration before going to court of law. The Arbitration shall be conducted at New Delhi and shall in English Language. The Court of Delhi shall have the jurisdiction.
