TERMS AND CONDITIONS FOR HIRING OF Back Hoe Loader Machine

1. Bidders will have to deposit Rupees 30,000/- for the tender of hiring of Back Hoe Loader Machine (With Diesel & Operator) as earnest money before participating in the Bid. The end of the successful bidder will be converted into security deposit at the time of award of contract.
2. Bid validity will be 90 days from the opening of financial bid.
3. All the tenderers /bidders will have to submit sealed tender for hiring of Back Hoe Loader Machine on per Hour basis. The lowest tender/bid may be negotiated, if required.
4. The tender form shall be filled by the parties in all respect with complete address.
5. The quality of operation shall be decided by the farm authority and the Contractor must ensure good quality of work.
6. The Contractor is not allowed to put their machine in an area not allowed by the farm authority.
7. The work will be carried out in the presence of the supervisor of the farm.
8. In case of incomplete work as per our requirement the area left will be completed through other sources at the risk and cost of the contractor and earnest money will be forfeited.
9. The contractor will obtain the log book for Back Hoe Loader from the workshop office and daily completion of the log book will be required. The responsibility of getting completed log book will be of the contractor and the log book must be available with machine for checking by the Supervisory staff.
10. The reading for calculation of hours will be engine running hours reading of the machine. The running hours of engine of machine will start from workshop office and end at workshop office after the completion of work. The engine running hours meter of the machine should always be in working condition.
11. The farm will not be responsible for any kind of theft of the machine or its parts and contractor will have to arrange for its safety at his own inside the farm area.
12. The payment of the bills will be made after producing of the log book and satisfactory inspection report of the farm authority and tax as applicable will be deducted from the bill.
13. The Head Farm reserves the right to discontinue the engagement of the machine without assigning any reasons.
14. The Head of the farm reserves the right to accept or reject the rates of tender/bid without assigning any reason.
15. An agreement of the contract on the above terms and conditions shall be made on Stamp paper, the cost of which will be borne by the contractor. The contract may be extended for upto 02 years upon successful work done by the contractor with mutual acceptance of the contractor and the farm
16. The earnest money of success bidder (s) shall only be released after successful completion of the work within the above terms and conditions.
17. Head Farm reserves the right to change the working time, if required depending upon the prevailing circumstances.
18. If any bidder fills more than one tender form in the duration of the tender then both the tender forms on his name will be cancelled.
19. Bidder should not be blacklisted/debarred from any govt organization and should submit the undertaking for non blacklisting as per annexure 4 at the time of technical bid.
20. The bidder/contractor will be responsible for submission of all the taxes for those works where GST is applicable. The bidder will have to submit separate bill for such works. The

taxes on agricultural works is exempted as per GST Notification No. 11/2017/CT (Rate) Dated 28-06-2017). If any changes will be made in GST the same will be applicable from time to time.

21. The bidder has to submit all the bills before 7th date of every month and the payment will be processed after verification of bills.

ARBITRATION:

In case any dispute arises between NSC and the other party due to any term or matter, both the parties will opt to resolve it through mutual understanding and discussion. In case, dispute remains even after discussion, then it shall be binding upon the parties to resolve the issue under the provisions of Arbitration & conciliation Act, 1996 as amended from time to time. Under this provision, the Chairman Cum Managing Director, National seeds Corporation Ltd. With the concurrence of both the parties shall appoint Sole Arbitrator to resolve the issue and both the parties will have to abide by the decision. The Arbitration shall be conducted at New Delhi and shall be in English Language. The court of Delhi shall have the jurisdiction.

JURISDICTION:

The parties hereby irrevocably consent to the sole jurisdiction of the Courts of New Delhi only in connection with any actions or proceedings arising out or in relation to this Tender.
