National Seeds Corporation Ltd. (NSC) being appointed as the Project Logistic Agency by the Department of Animal Husbandry and Dairying, Ministry of Fisheries, Animal Husbandry and Dairying, GOI, invites your quotation for courier/logistics services for transportation of vaccine samples from manufacturing units in Hyderabad to designated ICAR laboratories for quality testing.

The Designated Laboratory Destinations are:

1. ICAR – Indian Veterinary Research Institute (IVRI), Bareilly, UP-243122 (fixed laboratory)

One additional laboratory from the following (subject to change based on lot/batch):

1. ICAR – CCS, National Institute of Animal Health, Baghpat, UP-250609
2. ICAR – IVRI, Hebbal, Bangalore, Karnataka-560024
3. ICAR – International Centre of FMD, Argul, Bhubaneswar, Odisha-752050

Scope of Work & Terms and Conditions

1. The responsibility for proper and compliant packaging, sealing and labeling of vaccine samples lies with the Manufacturer/NSC. The Cold packs shall be properly placed inside the vaccine transport boxes by the Manufacturer/NSC to ensure that the internal **temperature is maintained between 2°C to 8°C for a minimum duration of 48 hours.**

2. The samples shall be handed over at Hyderabad Airport or another designated point mutually agreed between NSC and the logistics provider. The courier/logistics agency must arrange for dedicated vehicles from pickup to delivery point.
3. The courier agency shall ensure delivery of vaccine samples to the designated laboratory within 48 hours of handover from the Manufacturer/NSC. Any delay beyond 48 hours will render the consignment ineligible for payment.
4. Temperature loggers/data loggers will be arranged and inserted by the Manufacturer/NSC. The courier agency must ensure that cold chain is maintained during all legs of transport, including during airport handling.
5. The agency must deploy proper vehicle for transportation of samples.
6. It shall be the sole responsibility of the courier agency to ensure: No tampering, opening, or breach of sample packaging. The confidentiality and security of the consignment must be strictly maintained. Any tampering or damage enroute will lead to rejection of the service and liability for the cost of the sample consignment.
7. NSC will provide all necessary dispatch-related documentation (including any air waybills, declarations, and test request forms). The courier agency must comply with relevant national/international norms for handling vaccines.
8. Payment shall be made within 7 days from the date of satisfactory receipt of the vaccine samples by the laboratory within 48 hours from handover. The following documents are to be submitted along with the invoice:
 - a. Proof of delivery (with receiving signature/seal of lab)
 - b. Copy of Airway Bill (AWB) or courier tracking number
9. The courier agency shall be fully responsible for any loss, damage, delay or deterioration of vaccine samples during transit. Insurance, if considered necessary by the courier service provider shall be borne by the service provider.
