2. BID PREPARATION

- a) Bidder should take into account any corrigendum published on the tender document before submitting their bids.
- b) Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid.

3. BID SUBMISSION

- a) The tender must fill the technical and financial document sheet as provided in the bid document and need to put in tender box which is kept in our office premise before the due date and time.
- b) After completion of submission time and date, no bids/tender will be accepted.

4. AMENDMENT OF BID DOCUMENT

- a) At any time prior to the deadline for submission of proposals, the department reserve the right to add/modify/delete any portion of this document by the issuance of a Corrigendum, which would be published on the website and will also be made available to the all the Bidder who has been issued the tender document. The Corrigendum shall be binding on all bidders and will form part of the bid documents.

5. ADDITIONAL INSTRUCTIONS FOR VENDORS

- a) Bidders must have a valid email id and mobile number.
- b) Bidders are advised to read complete BoQ/SoQ/Price Bid/Financial Bid and Terms & Conditions before quoting rates in the bid document.
- c) Any modification/replacement in BoQ/SoQ/Price Bid/Financial bid template is not allowed. Bidders must quote only in predefined fields in the bid sheet and save the bid sheet.

1. The Period of tender for Hiring of Combines for Harvesting season 2025-26 (Nov-25 to Feb-26) for Fodder Sorghum and Jute crops. The details are furnished as under:

3. The amount of Earnest Money Deposit (EMD) will be converted into security deposit of the successful tenderer and for other it will be refunded without interest.
4. EMD exemption is applied for valid MSME parties (must be related to similar works) and If MSME party is awarded the contract then the party needs to submit security deposit of Rs. 70,000/- (Rupees Seventy Thousand Only) before starting of contract. The security deposit of the successful tenderer will refunded after successful completion of contract without any interest.
5. The total area proposed for harvesting of Kharif crops by combine harvesters is approximately **246 hectares**, including fodder sorghum and jute crops of different varieties during the Kharif season 2025-26 (period from November 2025 to February 2026, approximately). The actual area for combine harvesting and time period for harvesting may vary depending on crop maturity, shattering losses, and the extent of manual harvesting. The competent authority reserves the right to increase or decrease the harvesting area after assessing the actual crop and field conditions. The tenderer shall be bound to carry out combine harvesting operations for the allotted area at the quoted rates, without imposing any additional conditions. Failure to comply will lead to blacklisting of the tenderer and forfeiture of the EMD/Security Deposit.
6. The requirement of combine harvesters for harvesting fodder sorghum and jute areas will be informed to the contractor/representative one day in advance prior to the commencement of each day's operations. The contractor shall complete the assigned harvesting area within the stipulated time as per the demand of this office. Any loss incurred due to delay or failure in completing the harvesting operations on time as per our demanded area will be recovered from the concerned contractor.

7. The contractor shall be responsible for arranging suitable combine harvesters, qualified drivers, fuel, and for the protection and maintenance of their machinery/implements provided during the contract period. The farm will not be responsible for any mishaps, damages, or losses related to the contractor's machinery, implements, drivers, or personnel.
8. The Tenderer have no rights to modify the rates or return back once the tender submitted.
9. The tender will be given for harvesting Kharif 2025-26 season only (period from November 2025 to February 2026, approximately).
10. Payment will be made within 30-45 working days after achieving all targeted harvesting area of Kharif 2025-26.
11. After completion of daily operations, the contractor or their authorized representative shall submit a duly filled output report, in the prescribed office format, to the Engineering Section. The report must bear the signature of the concerned Chak In-Charge and Unit in charge/Production In-Charge. Payment will be processed based on the report certified by the Chak in charge/Unit In-charge and Production In-Charge.
12. The Security deposit will be returned back to the work allotted contractor after successfully completion of contract.
13. The Successful tenderer will not have any rights to transfer his contract to any other contractor.
14. Conditional Tender submitted by the tenderer will not be accepted.
15. Any of the tender or fax/letter/e-mail will not be accepted after opening of the tender.
16. The contractor is responsible for harvesting of crops without any seed damages due to improper machinery setups within stipulated time and harvesting with minimum field losses and seed damages as per guidance of Production section of our Farm.
17. Any losses in harvesting of crops due to improper harvesting, damaged seed output due to improper machinery setting, not proper running condition of combines will be recovered from contractor including forfeiting of his amount & rejection of contract.
18. If any kind of tax/permit, etc. is applicable for hiring of combines will be borne by the contractor only.
19. Losses, if any/damage in farm premises caused by the contractor or his personals will be recoverable from the contractor including termination of his contract.
20. The contractor will have to abide by the rules/instructions given by competent authority.
21. The contractor or his personal will be prohibited from preying/hunting of wild life in the farm. If they do so, they will be held responsible and the offence will be punishable as per existing rule of law.
22. If the contractor found violating any terms & condition, farm has every right to cancel his contract and forfeit his EMD or security deposits.
23. Tenderer will have to deposit photocopy of his Voter ID/Ration Card and PAN Card/Address Proof. If any letter or information not reaches to the contractor due to incorrect or incomplete address, the farm will not be responsible.
24. The Competent Authority has rights to reject/cancel the whole/part of tender/auction without assigning any reason thereof.
25. If the contractor's behavior is not found satisfactory and found not abiding the terms & condition of the tender after repeated warning, Farm has rights to cancel his tender or and also blacklist him for a period of minimum 02 years so that he will be disqualified for participating any tender/auction of the corporation.
26. For EMD exempted L-1 party, a period of only one week will be allowed for depositing of security deposit after award of contract. If not so, extra one week time will be allowed with interest rate of 18% p.a if the competent authority allows it. If the amount will not be deposited in the given time, the whole amount will be forfeited including EMD or Security deposits and also contract will be cancelled. During re-tender if the rates are received below his rates, will be the responsibility of said contractor and loss will be recovered from him. For EMD deposited L-1 party, the EMD will be converted to as Security deposit.

27. An agreement agreeing the above terms & conditions duly signed by contractor with two witnesses on stamp paper of Rs. 500/- may be submitted immediately after issuing the work order.
28. If any dispute/difference/disagreement arise between the parties and unable to settle mutually may be referred to the sole arbitration to the Chairman Cum Managing Director of National Seeds Corporation Limited or other person appointed by the CMD, as arbitrator and their decision will be final which will be acceptable by both parties. However, in case of legal aid, New Delhi court is only the jurisdiction.

SETTLEMENT OF DISPUTES:

In case any dispute arises between NSC and the other party due to any term or matter, both the parties will opt to resolve it through mutual understanding and discussion. In case, dispute remains even after discussions, then it shall be binding upon parties to resolve issue under the provisions of Arbitration and Conciliation act 1996 as amended from time to time. Under this provision, the Chairman-cum-Managing Director, National Seeds Corporation with the concurrence of both the parties shall appoint Sole Arbitrator to resolve the issue and both the parties will have to abide by the decision. The parties will bind to resolve this dispute through arbitration before going to court of law. The Arbitration shall be conducted at New Delhi and shall in English Language. The Court of Delhi shall have the jurisdiction.
