INSTRUCTIONS TO BIDDER – ONLINE MODE

DEFINITIONS:

- **E-Nivida:** Service provider to provide the e-Tendering Software.
- **NSCL e-Procurement Portal:** An e-tendering portal of National Seeds Corporation Limited (“NSCL”) introduced for the process of e-tendering which can be accessed on <https://indiaseeds.eproc.in>.

I. ACCESSING / PURCHASING OF BID DOCUMENTS:

- It is mandatory for all the bidders to have Class-III Digital Signature Certificate (With Both DSC Components, i.e. Signing & Encryption) from any of the licensed Certifying Agency under CCA, Ministry of Electronics and Information Technology, Government of India to participate in e-tendering portal of NSCL. Bidders can see the list of licensed CA's from the link www.cca.gov.in.
- To participate in the e-bid, it is mandatory for the Applicants to get themselves registered with the NSCL e-Tendering Portal (www.indiaseeds.com, <https://indiaseeds.eproc.in> and <https://indiaseeds.enivida.com>) to have a user ID & Password which has to be obtained by submitting a non-refundable annual registration charges of Rs. 3416/- inclusive of all taxes through **online** mode. Validity of Registration is 1 year.
- The amendments / clarifications to the tender, if any, will be posted on the NSCL e-Tendering Portal.
- To participate in bidding, bidders have to pay EMD (refundable) as per the amount mentioned in the tender document online through NEFT/RTGS after generating E-challan from <https://indiaseeds.eproc.in>.
- To participate in bidding, bidders have to pay Tender Processing Fee of Rs. 236/- inclusive of all taxes (Non-refundable) through online mode (internet banking/debit card/credit card).
- The Bidder may modify or withdraw their bid after submission prior to the Bid Due Date. No Bid shall be modified or withdrawn by the Bidder after the Bid Due Date and Time.
- Both 'EMD' and 'Tender Document Fee' are mentioned in individual tender document as published at NSCL e-Tendering Portal (<https://indiaseeds.eproc.in>).
- It is highly recommended that the bidders should not wait till the last date of bid submission to avoid complications like internet connectivity issue, network problems, system crash down, power failure, browser compatibility issue, system compatibility issue, improper digital signature certificate problem etc. In view of this context, neither M/s National Seeds Corporation Limited nor M/s. **E-Nivida** will be responsible for such eventualities.

1) PREPARATION SUBMISSION OF APPLICATION

Tenderer / Bidder can pay tender document Fee as per tender document online through Internet Banking/ Debit Card/Credit Card.

A Tenderer / Bidder manual containing the detailed guidelines for e-tendering system is also available on the portal.

2) MODIFICATION/SUBSTITUTION/WITHDRAWAL OF BIDS:

The Bidder may modify, substitute or withdraw its e-bid after submission prior to the Bid Due Date. No Bid shall be modified, substituted or withdrawn by the Bidder on or after the Bid Due Date.

Any alteration / modification in the Bid or additional information supplied subsequent to the Bid Due Date, unless the same has been expressly sought for by the NSCL, shall be disregarded.

For modification of e-bid, bidder has to decrypt its old bid from e-tendering portal and upload /resubmit digitally signed modified bid.

For withdrawal of bid, bidder has to click on withdrawal icon at e-tendering portal and can withdraw its e-bid.

3) OPENING AND EVALUATION OF APPLICATIONS

Opening of Applications will be done through online process. However, Corporation reserves the right for evaluation and decision based on tender submitted online. NSCL shall open documents of the Application received in electronic form of the tender on the Application due date i.e., in the presence of the Applicants who choose to attend. NSCL will subsequently examine and evaluate the Applications in accordance with the provisions set out in the Tender Document. The price bid will be opened of the responsive applicants. The date of opening of price bid will be notified later on.

4) DISCLAIMER:

The vender must read all the instruction in the RFP and submit the same accordingly.

INSTRUCTIONS TO THE TENDERES / BIDDER

ADVICE FOR BIDDERS:

The Bidders are advised in their own interest to carefully read the tender documents and understand their purport unless the Bidder specifically states to the contrary in respect of any particular clause, it shall be presumed that they accept all the terms and conditions as have been laid down in tender document.

Tender Cost (Non-Refundable): Tender cost Rs 590/- (Rupees Five Hundred Ninety only) (Including GST) pay in online/ Offline/ Online mode.

Earnest Money Deposit (Refundable): EMD amount Rs. 10000.00 per acre (Rupees Ten thousand only) must be paid before due in online mode or can be furnished as mentioned in the terms and conditions of the tender.

Eligibility Criteria: Any person having valid PAN, Identity Card, Address Proof and Bank Account will be eligible.

Submission of Offer: Offer must be submitted in prescribed tender input form in Online/ Offline/ Online Mode only. Only that party should tender who accepts all the terms & conditions because conditional tender may be treated as void.

BID OPENING AND EVALUATION: Bids will be open in Offline/ Online mode.

AWARD OF CONTRACT: The technical bid will open first and based on the purchase / sale committee will scrutinize the bid submitted and evolve the successful bidder for financial bid. Purchase / sale committee will award the Contract to the successful Bidder whose bid has been determined to be substantially responsive and has been determined as the best evaluated bid provided further that the Bidder is determined to be qualified to perform the Contract satisfactorily, for which the Firm may be asked for making a presentation, along with other parameters.

Notification of award: Prior to the expiration of the period of bid validity Selection Committee will place a firm order or notify the successful Bidder in writing.

Cancellation of Work order: NSC reserves the right to cancel the contract at any stage (by giving the notice in writing) due to non-satisfactory services of the selected firm.

TERMS AND CONDITIONS

1. As per the tender/auction notice for the sale of firewood collected and lying in the possession of the Central State Farm, Jawalagera, it has been decided to sell the estimated firewood weight in specified lots.
2. The collected firewood shall be sold through e-tender, auction, or tender-cum-auction. The sale shall be on an “as is where is” basis. The tenderer/bidder is deemed to have fully understood and accepted the terms and conditions of the sale. Before participating in the e-tender/auction, the bidder must physically verify the quality, quantity, and location of the trees/wood. After the sale, the bidder shall have no right to raise any claim or dispute in this regard.
3. The quantity of wood in each lot, collected from self-fallen, dry, or dead trees, may increase or decrease.
4. Before participating in the tender/auction, the bidder must present at least two identity documents such as:
 - Election Commission Identity Card
 - Aadhaar Card
 - Driving License
 - PAN Card

If the bidder/contractor is a registered company, it must submit:

- Authorization letter issued by the company
 - Company registration certificate
 - Financial status details
 - List of board of directors
 - Any two identity documents mentioned above
5. The Farm authority reserves the full right to reject or cancel any tender/bid without prior notice and without assigning any reason. The farm will not be responsible if any letter or information fails to reach the bidder due to incorrect or incomplete address or delay/error by the postal department.
 6. Any person who:
 - has been blacklisted by any office/farm of the National Seeds Corporation,
 - owes outstanding dues to the Corporation,
 - has been declared a criminal by a court,
 - has been declared ineligible by the government,
 - is a minor,

-will be ineligible to participate in the e-tender/auction.

If such a person participates and the contract is canceled at any stage, the earnest money and security deposit will be forfeited and adjusted as per NSC rules.

7. Every bidder must deposit the Earnest Money Deposit (EMD) in the prescribed format before participating in the tender/auction, duly signed in acceptance of all terms and conditions.

The EMD may be deposited through Insurance Surety Bond, NEFT/RTGS/UPI, or Demand Draft drawn in favor of “**NATIONAL SEEDS CORPORATION LIMITED**”, payable at Sindhanur, or deposited to:

The EMD of the successful bidder shall be converted into a Security Deposit. The EMD of unsuccessful bidders shall be refunded within one week without interest. The Security Deposit shall be refunded upon successful completion of the contract without interest.

8. Cash deposited in bank envelopes will not be considered as a security deposit. If the deposited amount is less than the prescribed amount, the tender may be rejected. After depositing the EMD, the bidder will not have the right to withdraw or modify the quoted rates. Incomplete e-tenders will not be accepted. After opening the e-tender, any communication through fax, email, letters, or recommendations will not be entertained.
9. The successful bidder must deposit 25% of the accepted amount within 03 days, and the remaining 75% within 10 days from the date of issue of the sale approval letter.
 - If payment is delayed, the bidder must deposit the outstanding amount with 18% interest per annum within an additional 15 days.
 - If the full amount is not deposited even within the extended period, the earnest money and security deposit will be forfeited, and the contract will be automatically cancelled.
 - If the bidder fails to remove the purchased lot within the stipulated period, the deposited amount will be forfeited, and the farm reserves the right to resell the lot.
10. The bidder will collect wood only from the purchased lot. If any unauthorized tree is cut intentionally or unintentionally, the bidder must pay twice the value of the wood as a penalty.
11. Upon successful completion of the contract without damage to farm property or crops, the earnest money and security deposit will be refunded without interest.
12. The contract cannot be transferred to another contractor. If violated, the contract will be canceled and deposits forfeited. The contractor must submit a list of workers with addresses who will enter the farm for wood cutting and transportation. The contractor must comply with all rules and regulations issued by the Forest Department and applicable laws under the Forest Act.
13. The contractor must submit an Indemnity Bond stating that he will comply with all forest laws and bear responsibility for any violation.
14. If any unauthorized person is found cutting or auctioning trees, legal action may be taken. The sale will be strictly on “as is where is basis.” The farm will not be responsible for losses due to natural or unnatural causes such as fire, storms, lightning, disease, termites,

insects, or theft. The contractor or workers must not interfere with farm activities, cause damage to property, light fires, graze cattle, or perform unauthorized activities within the farm.

15. If the contractor's conduct is not satisfactory or is against the interest of the farm, the farm authority may terminate the contract and blacklist the contractor. Hunting, killing, injuring, or disturbing wild animals within the farm premises is strictly prohibited. The contractor shall not object to agricultural work carried out by the farm or exert pressure to alter farm schedules.
16. All taxes, fees, forest charges, municipal charges, and transit permit charges related to the sale of trees or wood shall be borne by the contractor. The contractor will arrange cutting, packing, loading and transportation at his own risk and expense. Roads must not be blocked during loading and transportation. Crops must not be damaged during operations. If any term of the contract is violated, the farm authority has the right to terminate the contract and confiscate deposited amounts.
17. Wood removal from the farm will normally be permitted between 8:00 AM and 5:00 PM on working days, with a valid gate pass. The contractor shall not attempt to offer bribes, gifts, or threats to farm officials. Violation may lead to cancellation of the contract and legal action.
18. After approval of the contract, the contractor must execute an agreement on stamp paper of Rs. 500 and submit an Indemnity Bond on Rs. 500 stamp paper, signed by two witnesses within 07 working days. In case of disputes, both parties shall first attempt resolution through mutual discussion. If unresolved, disputes shall be settled under the Arbitration and Conciliation Act, 1996.

ARBITRATIONS

In case of any dispute arises between NSC and the other party due to any term or matter, both the parties will opt to resolve it through mutual understanding and discussion. In case, dispute remains even after discussions, then it shall be binding upon parties to resolve issue under the provisions of Arbitration and Conciliation act 1996 as amended from time to time. Under this provision, the Chairman-cum- Managing Director, National Seeds Corporation Limited with the concurrence of both the parties shall appoint Sole Arbitrator to resolve the issue and both the parties will have to abide by the decision. The parties will bind to resolve the dispute through arbitration before going to court of law. The Arbitration shall be conducted at New Delhi and shall be in English Language. The Court of Delhi shall have the Sub jurisdiction.

The terms and condition have been announced/ readout before the auction and/or told to me in my local language.

I have gone through the terms and condition of the above contract or I have been explained the essence of the contract in my local language and I hereby agree & abide by the above condition and all these terms & condition will be part of agreement between Central State Farm, Jawalgera and me.
