3. The material is offered for bid strictly on "AS IS WHERE IS BASIS" the office reserves to right to add/withdraw any lots or items before the start of the auction. In addition to above, quantity can also be increase/ decreased as per availability.
4. All taxes such as octree, sales tax or any other tax, if leviable by any authority up to the ultimate destination of the purchaser, are payable by buyer. However, the sales certificate may be issued by the office if required.
5. **All kinds of taxes shall be borne by bidder or purchaser only.**
6. The Corporation/office reserve the right of accepting or rejecting any or all the bids received without assigning any reasons to the bidders. The decision of the Corporation will be final conclusive and legally binding to all bidders.
7. The tender rates will be kept valid for 60 days, if necessary which can be extended up to 7 days at the discretion of the Corporation/ office. The Chairman-cum-Managing Director of the Corporation will take the final decision of accepting or rejecting the bid received for disposal.
8. The Earnest Money Deposit [EMD] of the successful bidder shall be adjusted in the bid amount. The EMD of unsuccessful bidder shall be returned within one month of the auction date without any interest.
9. The material is to be lifted after full payment within 25 days of issue of acceptance letter, after which ground rent @ Rs. 25/- per day/ item will be charged up to next 30 days only. If successful bidder fails to do so then the corporation/office may forfeit the deposited EMD amount by the bidder
10. If the purchaser/bidder fails to deposit the balance amount due within a period of 45 days from the date of issue of acceptance letter, then the corporation/office may forfeit the deposited EMD amount by the bidder.
11. If the purchaser/bidder fails to lift the material within given period, the Regional Manager - Jaipur reserve the right to auction or dispose off the earlier auctioned goods in a manner he deems proper and fit, at the risk and responsibility of previous bidder purchaser.
12. The delivery of the auctioned material will be made on any working day during working hours i.e. 10 AM to 5 PM.
13. In case the purchaser/bidder intends to take delivery of auctioned material through his representative, he should give the letter of authority duly counter signed by him.

However, in case of legal aid, New Delhi court is only the jurisdiction.

SETTLEMENT OF DISPUTES:

In case any dispute arises between NSC and the other party due to any term or matter, both the parties will opt to resolve it through mutual understanding and discussion. In case, dispute remains even after discussions, then it shall be binding upon parties to resolve issue under the provisions of Arbitration and Conciliation act 1996 as amended from time to time. Under this provision, the Chairman-cum-Managing Director, National Seeds Corporation with the concurrence of both the parties shall appoint Sole Arbitrator to resolve the issue and both the parties will have to abide by the decision. The parties will bind to resolve this dispute through arbitration before going to court of law. The Arbitration shall be conducted at New Delhi and shall in English Language. The Court of Delhi shall have the jurisdiction.
